*You must help CWA defeat a  
legal maneuver by Janet Reno's  
Justice Department that puts  
children at the mercy of pedophiles  
and child pornographers . . .*

Dear CWA Member,

A shockwave of anger and indignation has hit all pro-family senators and representatives on Capitol Hill. CWA is mobilizing for emergency response. Today I am asking you and our members nationwide to take immediate action.

For the sake of innocent children in America, it is absolutely essential that you understand the urgent situation we face.

The Clinton Justice Department filed a brief in the U.S. Supreme Court defending the "rights" of a convicted pedophile to possess, produce, or distribute pictures and videos blatantly created to entice the lust of pedophiles for young children.

For your immediate review, I have enclosed a copy of an actual trial exhibit from the case in question (Knox v. United States, U.S. Supreme Court Case No. 92-1183).

Please ensure that no child sees this enclosure. It is perverted and degenerate. And while I would never mean to offend you, you must see for yourself the type of obscene materials this president's attorney general says pedophiles have the right to distribute and buy.

Also enclosed for your immediate review and signature is an official CWA petition. I ask that you endorse and return it to me the moment you've finished my letter.

I must warn you. If this administration further weakens our nation's child exploitation and pornography laws, children in America will be at risk, and families in our country will be endangered.

Time is critical. I must be brief. Here are the horrifying facts:

\* Two lower courts convicted avowed pedophile Stephen Knox of child pornography after the U.S. Customs Service seized a collection of films from his apartment. The collection included materials entitled *Ripe and*

*Tender, Young Flashers, Sweet Young Things, Young and Tight, and Lollipops.*

- \* Knox appealed his conviction to the Supreme Court. Under Reno's direction, Solicitor General Drew Days filed a brief saying the films are not child pornography because they don't show the naked genital portions or the pubic areas of the young girls, nor do they show the children "lasciviously engaged in sexual conduct."
- \* In view of the Clinton administration's new position on child pornography, the Supreme Court has ordered the lower courts to retry the Knox case.

Congress is shocked! The Reagan and Bush administrations, along with pro-family leaders in Congress, passed tough child exploitation and pornography laws to protect innocent, unsuspecting children from pedophiles.

Through these stringent laws, many child pornographers have been convicted because they sold and distributed secret films of sleeping children or small kids playing at the beach and in parks--focusing on the children's genital areas without the knowledge of the child or parents. Under the Clinton administration these child pornographers and pedophiles would not be prosecuted.

And it means that any pervert with a video camera can go to a park or pool where your daughter or granddaughter plays and film her. Literally, the child you love could show up in tapes that pedophiles distribute and buy.


That's why I am requesting that you and all CWA members act immediately. First, please pray for our children and grandchildren. Attorney General Janet Reno and this administration are directly endangering their lives.

Second, carefully read the enclosed trial exhibit. Line by sickening line, it sets out the sin-filled perversity that the Clinton Justice Department is protecting.

Third, sign and return your petition at once. CWA will deliver your petition along with thousands of others to President Clinton. We are calling for the resignation of Attorney General Janet Reno if the Justice Department will not reverse its pro-pedophile position in child pornography cases.

Finally, I ask that you enclose an emergency gift to help CWA at this urgent time. When I was alerted to this crisis, our financial resources were already strained. And with extremely limited funds, we are mobilizing with congressional leaders to stop the destruction of our nation's child pornography laws. Your gift of \$35, \$50, even \$75 or more is crucial to help fuel our efforts.
