

A generation under attack

Based on the current AIDS crisis and the general crisis in heterosexual love, these last fourteen years of college and secondary sex education rate an "F." Sex education curricula suggesting homosexuality or homosexual experimentation as a viable "choice" for children has long been found in the nation's schools. Facilitated by Planned Parenthood and SIECUS (Sex Information and Education Council of the United States), the new wave in sex education has taken the form of "Male-Female Relations," "Family Life Education," "Human Sexuality" courses and the like.

After 14 years of instructing students about marriage, virginity, abstinence and prostitution, Planned Parenthood has also taught our children incorrectly about homosexuality, promiscuity, and other AIDS-productive behavior.

The new sex education was to be an improvement over Judeo-Christian teaching which had taught marriage as a basis for sexual relations. AIDS and the current epidemic of venereal diseases are traceable to promiscuity.

Yet, Planned Parenthood instructs:

"...Sex is best between friends. Not quickest, just best. Ask anyone who knows...Sex without [victimis] is always right...have sexual relationships only with your friends...If she's young, always ask...if this is a girl you've just met and she agrees, you're in the clear provided she's old enough to have some sense...with friends no faking is necessary...People do what they feel like doing..."

Is "young" a 10, 12, or 15-year-old girl, with "some sense?" Finally, Planned Parenthood and the teachers approving this instruction add:

"Sex is emotionally loaded. Only kids, drunks, and sickies play Russian Roulette with it..."

Does this mean that Planned Parenthood wrote and distributed "sex" manuals to "kids" in schools nationwide, knowing that they were playing Russian Roulette with our children's lives?

Therefore "kids," many of whom are using alcohol and drugs, are instructed sex is "always right" with friends. Much of today's youthful crisis reflects almost two decades of Russian Roulette sex instruction.

In January 1987, Ann Welbourne-Moglia, the Director of SIECUS, called AIDS "A time of rare opportunity." Homosexuals and pansexuals (Kinseyans) use the AIDS crisis which they created as an opportunity to attract massive numbers of young people into their thinning ranks. Already accessible because of alcohol/drug use, disillusioned by early forays into sex, seeking a humane "cause" and personal distinction, homosexuality looms large as the youth movement of the future.

Classes like "Family Life Education" in public, private, and even religious schools, generally teach youngsters that homosexual sex is morality, emotionally, and physiologically equivalent to heterosexual love. Since the AIDS crisis began much sex education, the President's AIDS Commission, the HHS/Koop mailer, etc., position homosexual rights as a "higher" cause. By helping, youngsters may attain visibility. Yet the evidence shows this "higher" cause of homosexuality is psychotic, largely pivoting upon AIDS-productive anal sodomy for sexual expression, with a mean of roughly 550 "partners" among homosexual men (not women); AIDS carriers average 1,100 partners.

The following excerpts from sex education curricula may be seen as evidence of a generation under attack. The power and influence of

the homosexual movement may be noted in the exclusion of important facts and the use of false and misleading statements about the origin of the AIDS epidemic in the federal government's \$17-million-dollar AIDS mailing, "Understanding AIDS." The mailing included 26 instances (roughly four per page) where homosexuality was treated as morally, legally, and emotionally equivalent to heterosexuality.

The homosexual revolution is breaking all about us. Electoral candidates are wooing homosexuals, erroneously believing this group represents from 10-to-37 percent of the voting public. On the contrary data suggests that only 1-to-2 percent of American males are homosexual with perhaps 5 percent having experienced some homosexual contact.

AIDS patient arrested on child porn charges

Officials in Washington recently said that a Defense Department elementary school teacher who has AIDS has been arrested on charges that he received child pornography through the mail. He is the subject of a broader child molestation probe.

The teacher, assigned to the department's Dependents School program in Panama since September 1985, was arrested after voluntarily traveling from Panama to Atlanta, Georgia. Military officials said the man was a U.S. citizen and second-grade teacher who is "an admitted homosexual suffering (from) AIDS."

Furthermore, while roughly 73 percent of the homosexual males in one study self-reported having had sex with boys, one in seven boys are identified as experiencing a child sexual assault, most often by male homosexuals.

It is the 1948 Kinsey report upon which these homosexual exaggerations (and the Centers for Disease Control estimates of homosexuality) are based. But, minimally 50 percent of Kinsey's 5,300 male subjects fell into four groups: sex experimental children and school-boys; incarcerated criminals/sex offenders; pre-selected homosexual activists; or "pimps," "feeble-minded," and assorted other non-normal males.

Kinsey did not recognize a distinction between voluntary and forced/coerced copulation. Therefore his statistics include numbers of males raped as youngsters, persons coerced into such activity, individuals who acted "under the influence," and so forth.

A pornographic text for youth, *One Teenager in 10* (Warner, 1985), advertises "The struggle, the exultation, and the poignancy of

being young and gay today." This text is provided to youngsters being "helped" with homosexuality at Fairfax High School in Los Angeles, California. This text is just one of many used in schools today. A brief overview of various school materials follows:

A Los Angeles, California school offers "Project 10," utilizing homosexual counselors who assist struggling youth with their sexual decisions. "Implementation of Project 10 will become a model for districts throughout the United States," promised *The United Teacher Magazine* in 1987.

Mutual Sharing, Mutual Caring is a sexuality education unit for adolescents that says gay and lesbian adolescents are perfectly normal and "their sexual attraction to members of the same sex is healthy."

The Western New York AIDS Program distributed materials to ninth graders in Buffalo that recommended "mutual masturbation, jerking off, manual stimulation, anal or vaginal stimulation/penetration with dildoes, fingers."

The sex education text, *Learning About Sex* states "...there are no special medical dangers associated with anal sexual contact...same-sex experience."

Sexuality: A Divine Gift, created by the Episcopal Church's Executive Council warns "Some of the most active anti-pornography groups include homosexuality and 'secular humanism' in the list of things they oppose." The material includes a recommended reading section listing The Gay Task Force of the American Library Association.

Same Sex Friendships is a sex education book with "A Homosexual Bill of Rights," used in conjunction with its highly explicit sex film. The book promises "sensible hygiene and concern for one's partner will enable couples to enjoy anal intercourse without ill effects."

Personal Issues in Human Sexuality includes a chapter called "It's Not OK to be Anti Gay." The chapter says it's fair to say that much of the alleged promiscuity among homosexuals is partly a response to the hostility of straights."

Love and Sex in Plain Language says, "Life for homosexuals in the present state of our society is made difficult because so many people condemn homosexuality as strange and abnormal and reject those who practice it...It's really impossible to masturbate too much."

Time magazine's June 7, 1982, issue featured an article titled "X-Rated Homework." The article talked about a California State University college professor whose students "could get classroom credit for after hours experiments: married couples indulging in adultery, for example, or straights having sex with gays."

It is time for Americans to find out who has taught the sex educators who instruct our children. All concerned parents should find out what myths are called "factual" instruction at your neighborhood school. Incorrect and potentially harmful tools like the Health and Human Services mailer, "Understanding AIDS" are being used as a sex and AIDS education curriculum in many school districts. Parents should evaluate the sex and health education in their schools and see if the curriculum is sending the wrong message to their kids.

Sexual mythology and recruitment is not limited to schools and colleges. The media, television, and radio often carry misleading and harmful messages. On December 14, 1987, *The Washington Post* elected to carry an advertisement by the Alexandria Gay Community Association. It cited the false Kinsey data as fact, saying: "1 in 10 sons is gay. If you are teaching your children to hate gays, you might be teaching one of them to hate himself." Parents are told "That's a form of emotional child abuse."

Do not underestimate the power of myth and the power of the homosexual revolution. The Surgeon General, appointed by the most conservative President in this century, equated "sexual intercourse...whether you are male or female, heterosexual, bisexual or homosexual," in his instruction on AIDS. More than 107 million American homes—and now school after school—received the message that homosexuality and heterosexuality are physiologically, emotionally, legally, and morally equivalent.

If we lose "one teenager in 10" to male homosexuality, the statistics suggest these vulnerable youngsters will also soon be lost to AIDS. I had not been among those who, early on, charged that sex education was a smoke screen to standardize immoral (individually and socially disastrous) behavior. However, never before has this nation faced such a federally funded attack upon its youth. Never before have our children so desperately needed our boldness, our guidance, and our courage to act swiftly in their and our nation's defense.

'Parents' magazine article says homosexuality acceptable alternative lifestyle

Parents magazine recently ran an article that was actually pro-homosexual in disguise. The article defended homosexuality, saying that it stems from varying "prenatal conditions which are determined at birth..."

The article also claimed that there is "indirect evidence" that homosexuality could be biological and genetic.

The pro-homosexual article went on to say, "...despite our beliefs that homosexuality is not morally offensive or perverted, we fear the effects that the prejudice of other people may have on our children should they turn out to be gay."

The article reported researchers at the Kinsey Institute in saying, "...We need not be overly cautious about the sexual orientation of our sons' teachers, coaches and adult friends...nor need we be overly concerned about our sons' early sex play with other boys causing homosexuality...it would probably make far more sense simply to recognize it (homosexuality) as a basic component of a person's core identity and to help the client develop more positive feelings about and respect for his or her sexual

proclivities."

On the other hand, Dr. George Rekers, Professor of Psychiatry from the University of South Carolina School of Medicine (who was not interviewed by *Parents* magazine), said his study offers overwhelming evidence refuting the claims of the *Parents* magazine article. He says that homosexual behavior is not inborn.

At a "Hope and Homosexuality" Conference, Dr. Rekers said that his studies of homosexuals have proven that homosexuality is not something that is innate, rather it is conditioned into a person, usually during early to middle childhood.

According to Rekers the childhoods of those who became homosexuals had two distinct features: the emotion of physical absence of the child's father and the presence of effeminate behavior and playthings together with an excessive attachment to female playmates and the exclusion of male playmates.

He stressed that homosexual behavior can be corrected. The earlier the behavior is recognized and treated, the better the results.

Homosexuals get coverage under new L.A. law

The Los Angeles City Council has voted

to recognize "domestic partners" as the immediate family of city workers. Backers of the measure acknowledged the plan could apply to homosexual as well as heterosexual couples.

Under the plan, city employees would be allowed to take sick time or bereavement leave for "domestic partners." Presently, immediate family is defined as a spouse and children. If the plan is ultimately adopted, benefits would be available for unmarried couples living together including homosexuals.

Homosexuals become major characters in prime-time

Producers of ABC's prime-time series THIRTYSOMETHING, Ed Zwick and Marshall Herskovitz, plan to add a homosexual character to the show. Producer Zwick said of the plans, "There is going to be a new character named Russell who is gay (homosexual) and who does not have AIDS..."

Positive portrayals of homosexuals are beginning to turn up often on network television. HEARTBEAT and HOOP! MAN also have homosexual characters who are presented in a positive manner.
