Language

Man-Boy Sex Data in *The Queens' Vernacular* (1972)

Webster defines language as: “The faculty of verbal expression and the use of words in human intercourse.” The analysis of *The Advocate* advertisements led to the discovery of the foremost homosexual dictionary, with its own encrypted “gay” language (see Appendix A). This analysis of *The Queens' Vernacular* (1972), republished unchanged as *Gayspeak* (1979), corroborates much of the data on male homosexual orientation.

Chicken: a young recruit; any boy under the age of consent, heterosexual, fair of face, and unfamiliar with homosexuality.

Head and heels: describing physical allurements despite extreme youth, too young or small to know what to do in bed: he must be helped by someone more experienced who will clasp the boy by his head and heels to lift him onto the c--k.

Jail Tail: boy below the age of consent with whom sex merits a stretch in the pen.

Poultry Dealer: man who pimps boys to interested homosexuals.

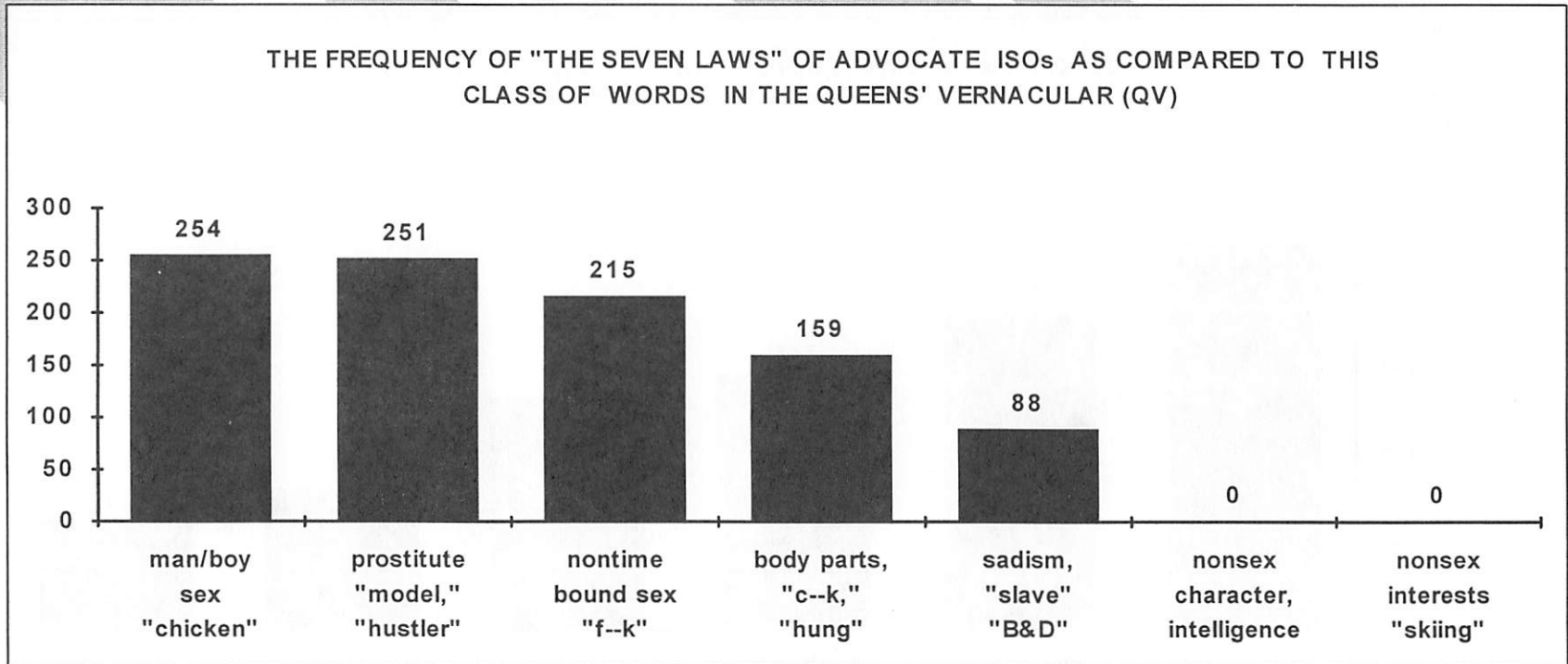
Pluck Some Feathers: to make love with a young boy, especially anally.

Butchered chicken...rip off a drumstick...skin some chicken (...to force a boy to come across). **chicken dinner; chicken looking;** chicken-little, pig meat, chicken feed, boy-eater, quail [Also see]: **wagette wag** = “little boy’s penis.”

Egg: a male child too young to be sexually developed...considered neuter.

Syn: peepee meat; yo-yo. Related terms: egg-sucker...a cradle robber; man who likes very young boys, **ready to crack** [hatch] open said of a boy on the verge of puberty.

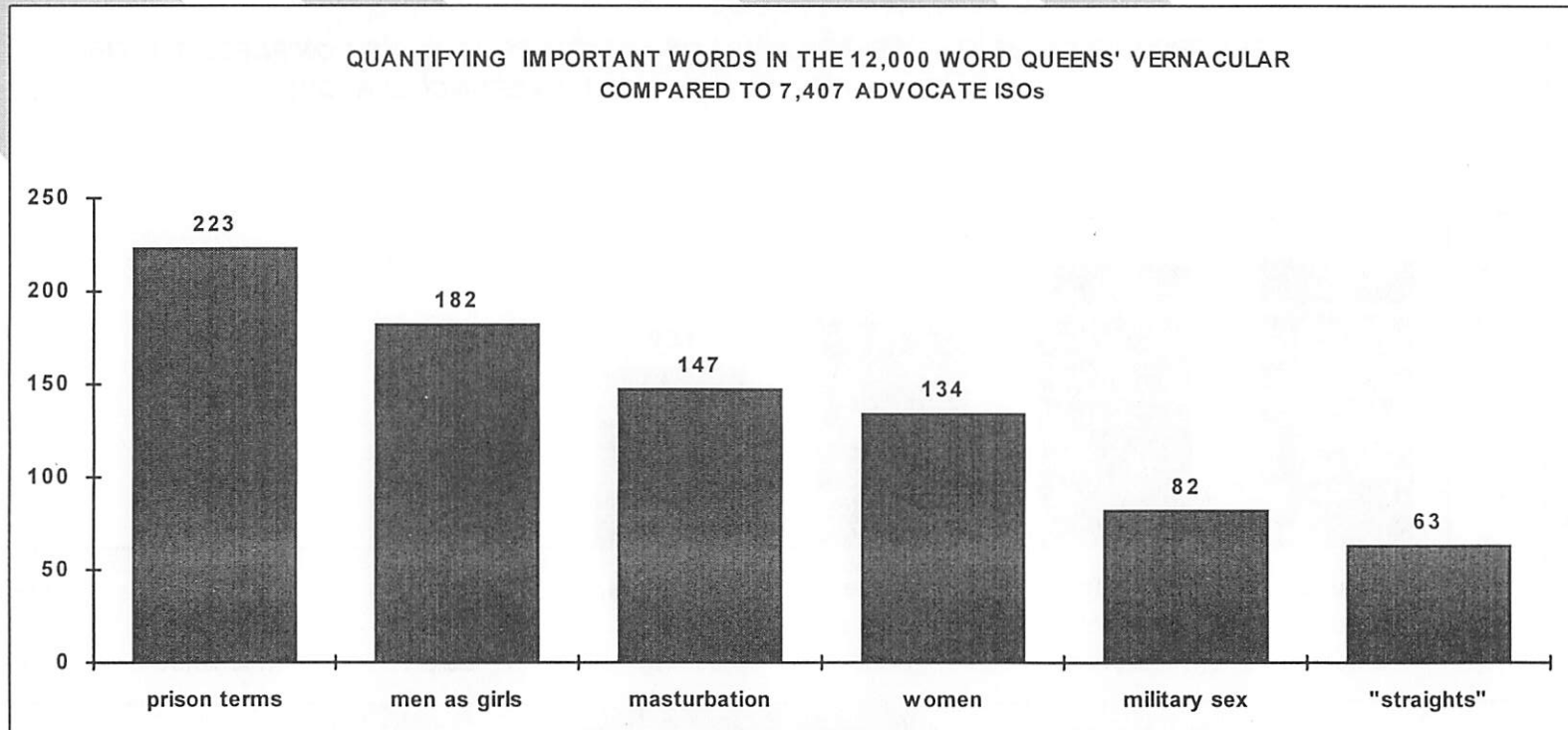
*Language As Corroborative Data in

- 4) The Phallus, Sexual Body Parts (e.g., "well hung," "meat")
- 5) Sadism, (e.g., "SM," "BD," "leather," "fu--ing buddies")
- 6) Nonsexual Character/Personality (e.g., sensitive, honest)
- 7) Nonsexual Interests, Activities (e.g., camping, swimming)

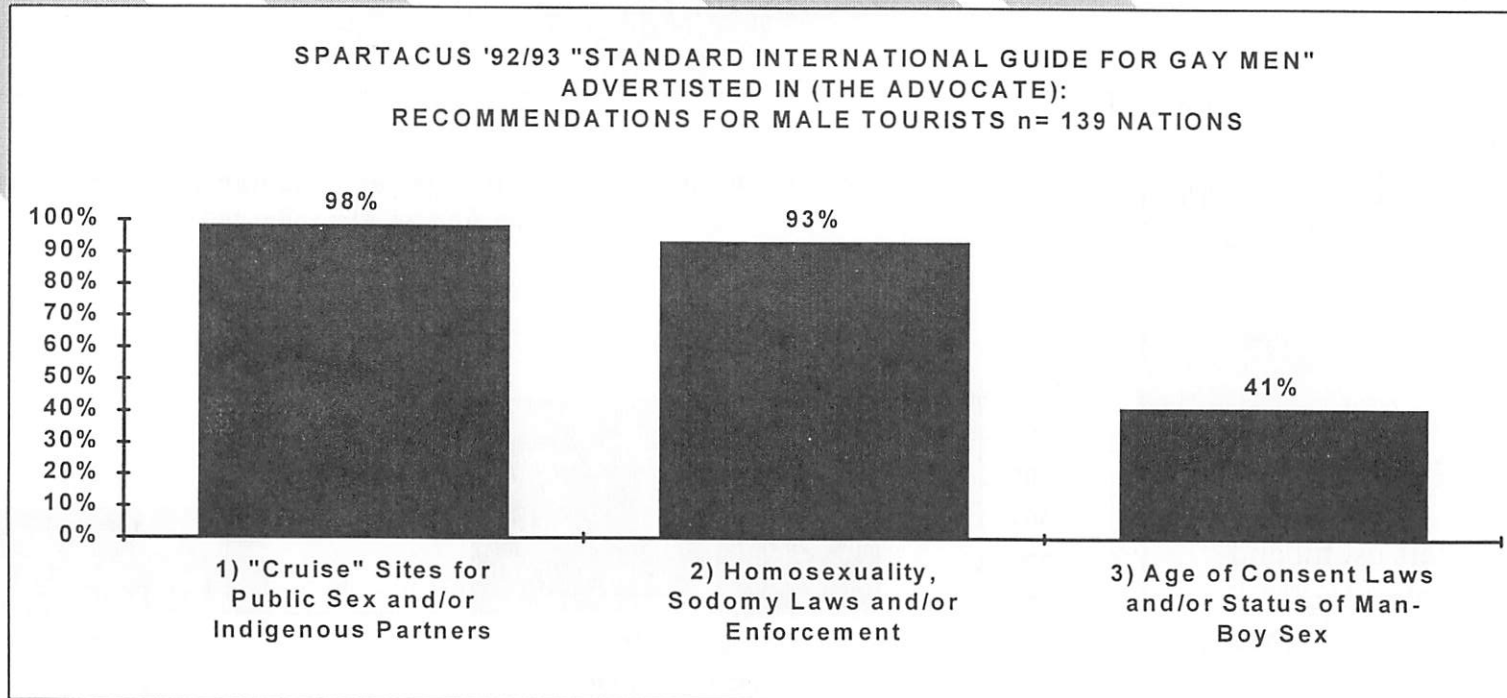
Language as Corroborative Data in The Study of Sexual Orientation

Homosexual Travel Guide as Corroborative Data



The legal status of homosexuality, sodomy, man-boy sex (pederasty) and sites for public sex are common features in *Spartacus*, the mainstream homosexual travel guide regularly advertised in *The Advocate*. Eroticized boys and ads for **pederast/pedophile** clubs appear beside "House of Boys" ads in Europe and Asia with the Thai government recently deporting the *Spartacus* editor for telling his readers how and "where to pick up boy prostitutes." (*The Advocate*, 9/19/95, p. 12), while in Manila, hundreds of young boys recently protested that a "syndicate" was running houses of boy prostitution, (*The International Herald Tribune*, 10/25/95, p. 8, first edition). No mainstream heterosexual travel guide currently advertises for pedophile clubs, prints eroticized photos of young girls beside "House of Girls" ads or cites age of consent laws and sites for public sex with local girls or women.

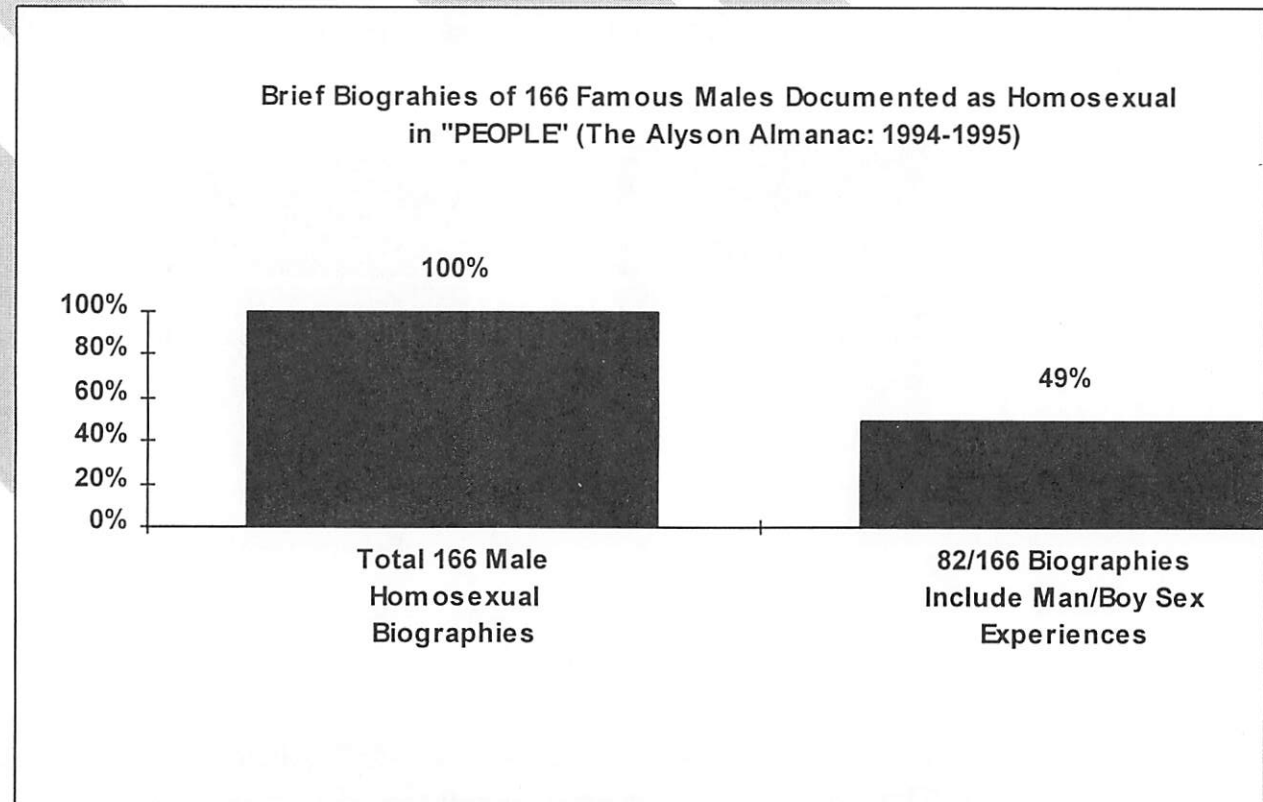

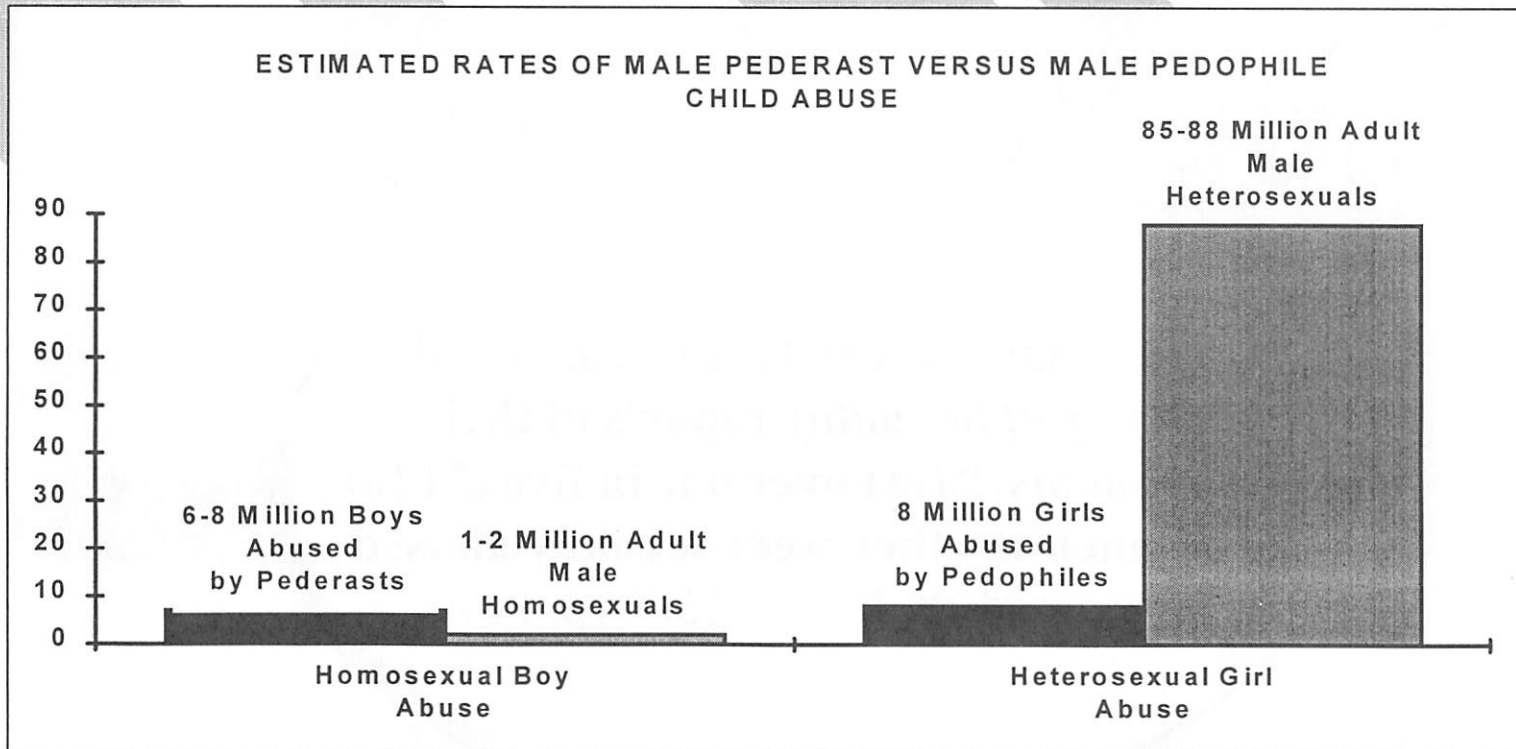

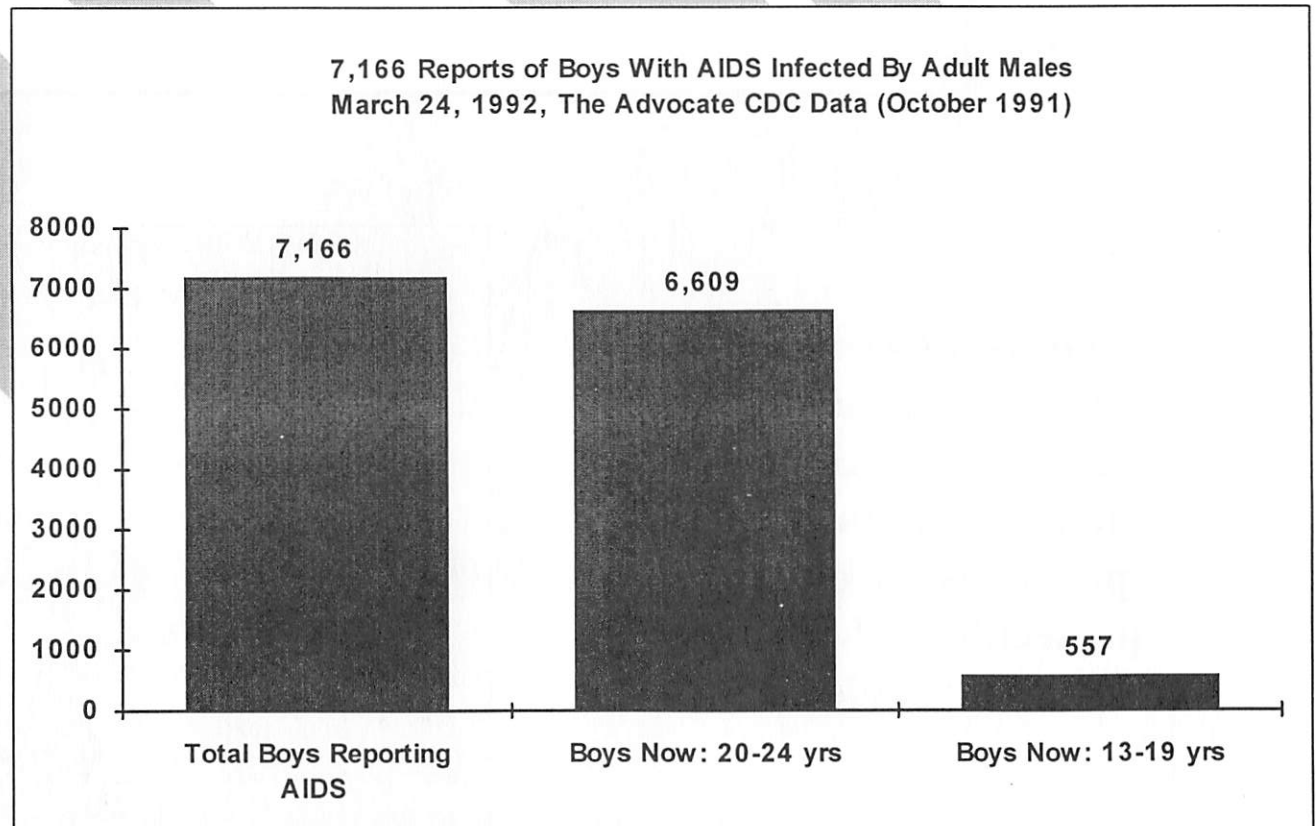

Heterosexual v. Homosexual Pornography Use



Most homosexual magazines were sexually exploitive (pornographic) in image and text, and 88% of the 26 most popular magazines included pornography, (#1) *The Advocate*, to the majority exclusively pornographic (#26) *Torso*.

The top 26 heterosexual magazines cited by *Advertising Age* were: (#1) *Reader's Digest* to (#26) *US News And World Report*. Begun in 1953, *Playboy* remains the lone erotic/pornographic title among the top 26 **heterosexual** magazines cited by *Advertising Age*.³ See full *Reisman & Johnson Report* for further documentation.

THE ADVOCATE IN PUBLIC AND SCHOOL LIBRARIES

The prior Addenda focuses on *The Advocate Classifieds* pre-isolation into a separate *The Advocate* periodical in 1992 when *The Advocate* gained entry into public and school libraries nationwide for adult and child access. *The Classifieds* remains an *Advocate* product, advertised and subscribed to therein. With the massive availability of boy pornography via new computer services, post 1992 *The Classifieds* reduced blatant pederast pornography as well as objects for sale (e.g., “Penetrable Boy Doll”)⁷ which had characterized the magazine since 1972.⁸ As the videos once largely available via *The Advocate Classifieds* of boys having sex while beaten by adults or older boys, are carried in “cyberspace” pornography, this increase in home availability reduced the use of boys in *The Classifieds* and opened the door to library inclusion. Some argue pederast media on computers and in public libraries suggest laws and public policies are not up to speed on this growing avenue for pornographic molestation and other crimes against children.⁹

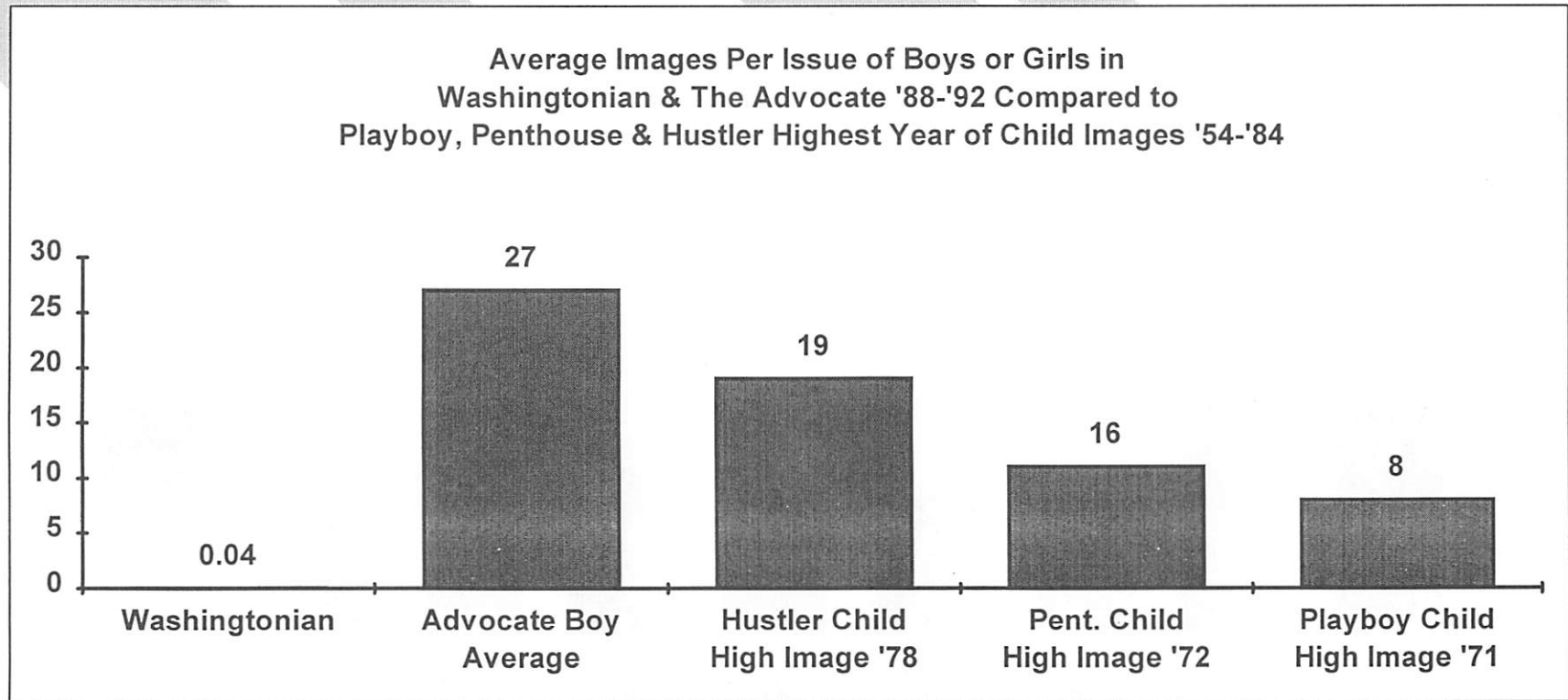

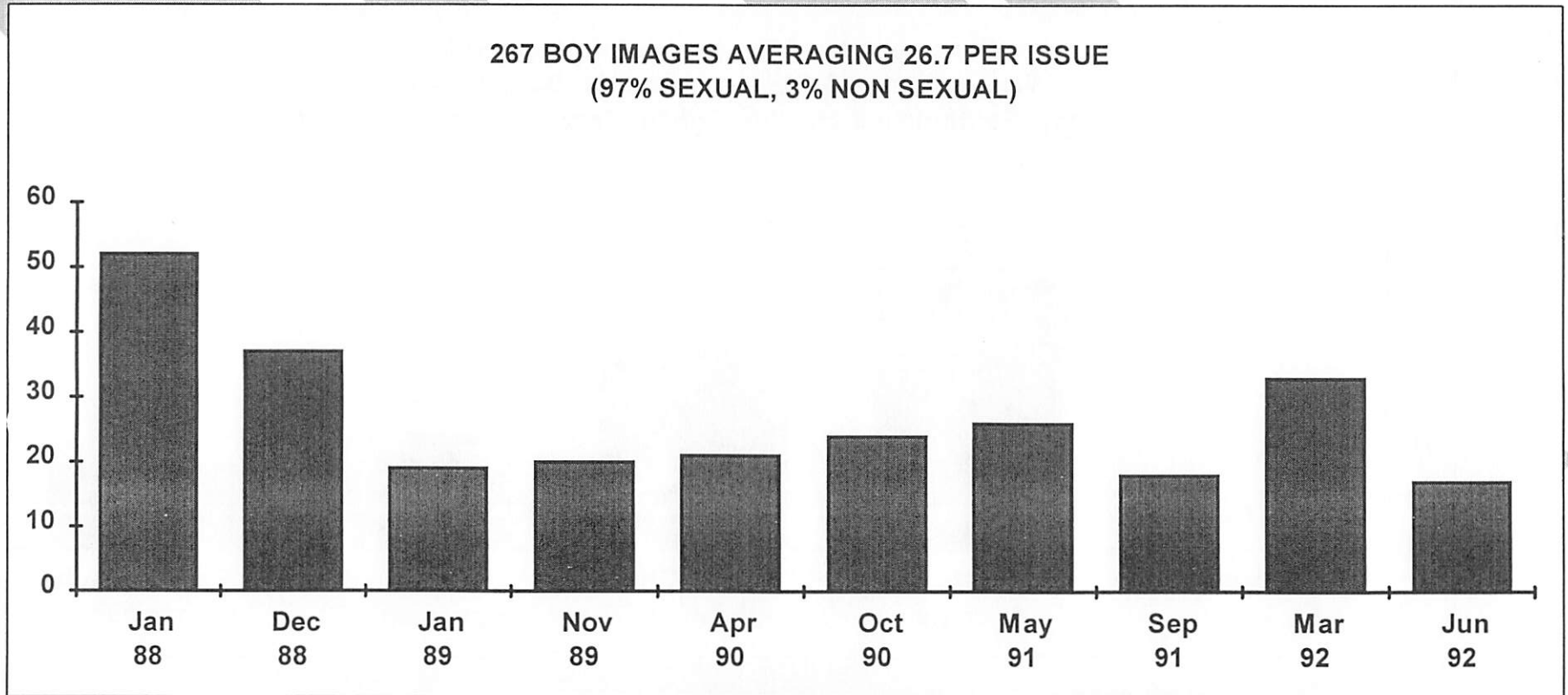
Pederast *Advocate* Images of Boys vs Heterosexual Pornography



It has been well established that eroticized child images **normalize child sex abuse**⁴. Averaging 27 boy photographs per issue, and this is the only heterosexual statistical comparison we find to **illegal child pornography**. We therefore compared *Advocate* imagery to the “soft” pornography data above: *Hustler* averaged 14 images of children; *Playboy* averaged 8 images; *Penthouse* averaged 6 images, in the highest years of child imagery. Also, while mainstream heterosexual pornography slowly desensitized readers beginning in 1954 to child-adult sex via cartoon, illustration to photograph⁵, from its earliest years, *The Advocate* eroticized boys (averaging 54 boy images per month) as viable adult sex targets.⁶

Pederast Erotic Boy Images in The Advocate 1982-1992



The **visual environment** and use of boys and girls is **dissimilar**. At two issues per month, *Advocates* average, per issue, 26.7 largely erotic “boy” images, marketing psuedo-child pornography films, with roughly 5% of these boys in images of violent abuse. Were heterosexual and homosexual male orientation alike, we should find *Advocate* erotic boy image similar to *Washingtonian* rates of erotic girl images. The data found erotic (pedophile) girl images statistically insignificant and no eroticized, or sadosexual “teen” girl images in the *Washingtonian*.

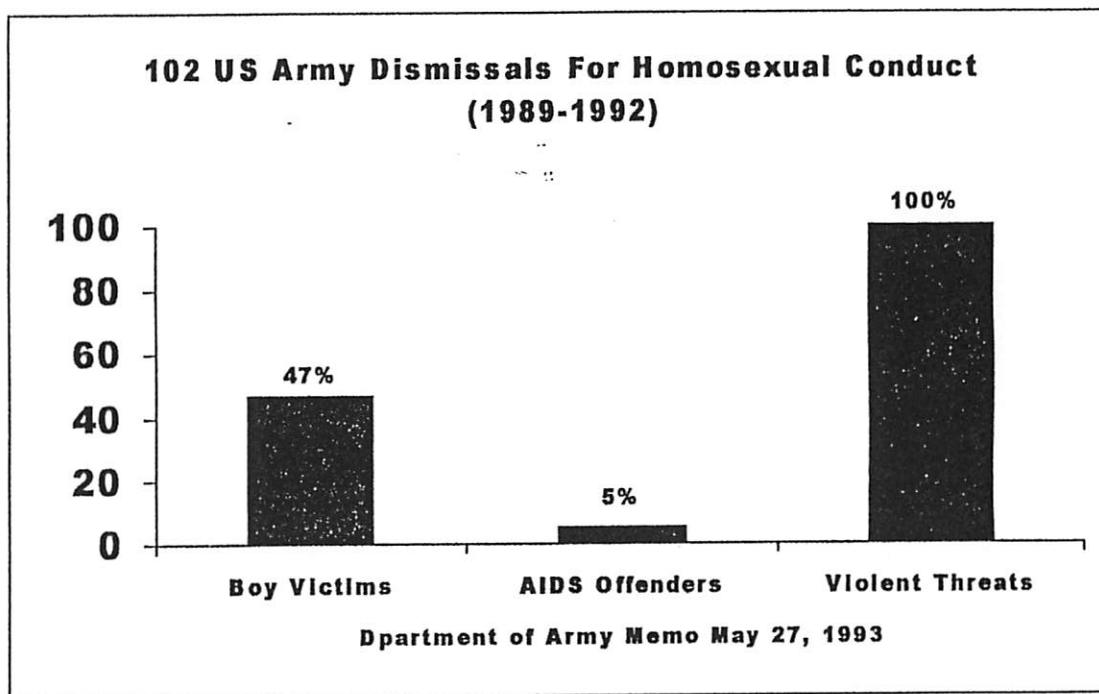

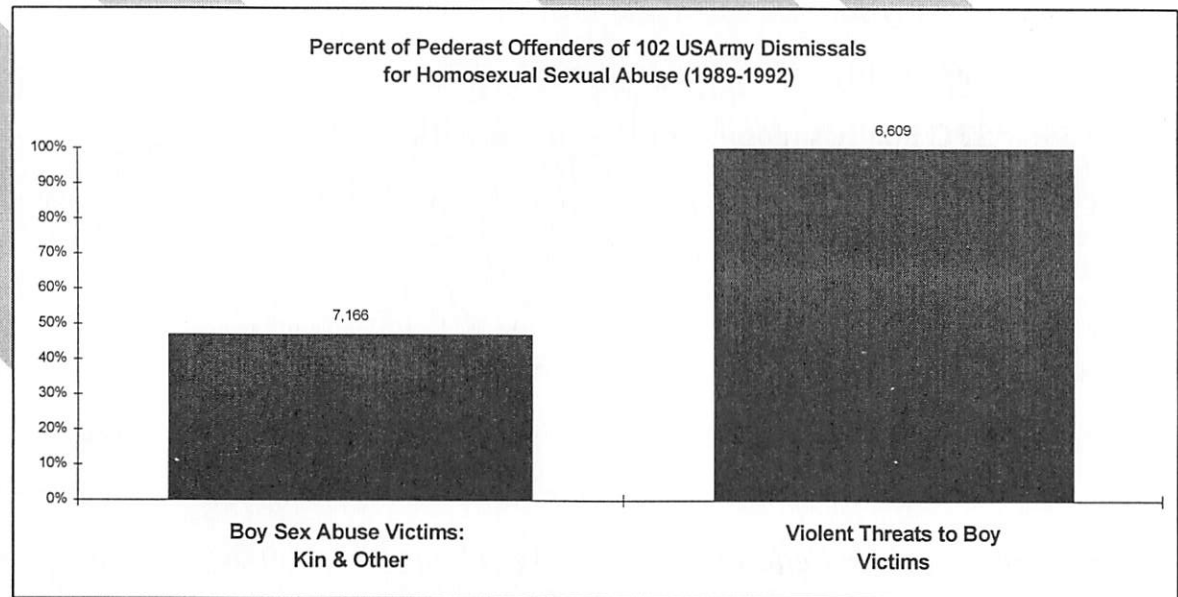

Case 35: "SPC, a Military Policeman, sexually abused his step-son... [anally]...less than three years old at the time."

Case 37: Assault of "3 1/2-year-old son."

Case 54: "...anally sodomize an eight year old neighbor boy."

Case 57: "PFC anally sodomized both boys...10 and seven."

Case 59: "SPC anally sodomized a 27-month-old child."

Case 65: "PFC gave the boy liquor...When the boy became ill...[he] attempted to anally sodomize the boy."

Pornography Specifically Identified as Tool

Case 19: "SGT forced SGT's son, then aged 8...anal sex...causing great physical pain to the boy...SGT placed a sock in the boy's mouth because the boy was screaming in agony...SGT taped one incident...on a video recorder."

Case 85: "PFC showed pornographic movies and played a computerized sex game with the boys" then sodomized them.

Case 38: "...daughter and son were made to watch a pornographic videotape" prior to the sexual assaults.

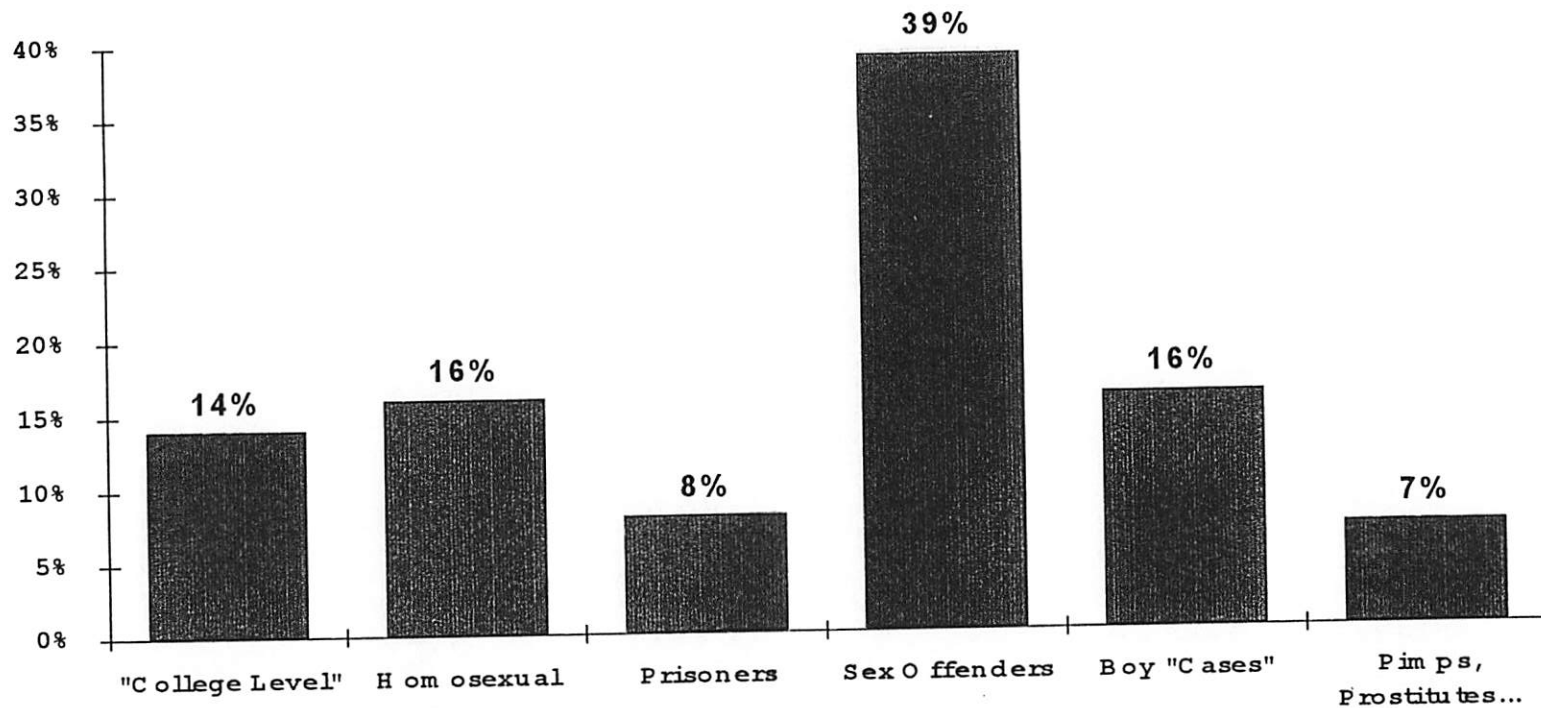
Military Case 33: "...Scoutmaster...anal sodomy on Boy Scouts aged 9 to 12 years. SGT used leather straps, dog collars, a dildo, and a dildo attached to the end of a policemen's night stick in the performance of these acts. SGT videotaped these acts...the child screamed, 'Oh God, please stop...Please, please stop.' SGT told this boy to 'Relax.'"

Military Case 60: "...as a Boy Scout leader...SGT molested two young boys..."

Military Case 91: "...an Assistant Scout Master...SPC molested young boys..."

JUDITH A. REISMAN, Ph.D., Principle Investigator

Dr. Judith Reisman, author of *Kinsey, Sex, and Fraud* (1990) and *"Soft Porn" Plays Hardball* (1991), was a consultant to the Departments of Justice, Education, and Health and Human Services and is listed in *Who's Who in Science & Engineering*, *International Who's Who in Education*, *International Who's Who in Sexology*, *Who's Who of American Women*, and *The World's Who's Who of Women*. In 1981, Dr. Reisman delivered her findings on Dr. Alfred Kinsey's fraudulent child sexuality data at the *Fifth World Congress of Sexology* where she called for an investigation of the criminal child "sexuality" tests supervised by Indiana University's Kinsey team. As such a fact-finding study was never undertaken by the academic community, *Kinsey, Sex, and Fraud* became necessary. These scholarly findings have had international impact with *The German Medical Tribune* and the British medical journal, *The Lancet*, calling for an inquiry into the Kinsey study. In *Kinsey, Sex and Fraud*, Dr. Reisman and her colleagues "demolish the foundations of the two reports...[including] stimulation to organism in young children...Kinsey...has left his former co-workers with some explaining to do", *The Lancet*, (Vol. 337: 3/2/91;547). James Shannon, former Massachusetts Attorney General: "I contacted Dr. Reisman in connection with an important child pornography case, *Massachusetts v. Oakes*...in the United States Supreme Court in January 1989...To make the point, I quoted Dr. Reisman's study, *'Images of Children, Crime and Violence In Playboy, Penthouse, and Hustler Magazines'*". Jim E. Crouch, Texas Assistant Criminal District Attorney: "As a prosecuting attorney, I have tried approximately 35 obscenity jury trials in which the defense has called a sociologist as an expert on community standards. Your book, *Kinsey, Sex and Fraud*, has proven invaluable on cross-examination...To be able to point out to the jury the fraud that Alfred Kinsey and his institute have perpetrated is a very effect tool." She "puts men's magazines on the endangered species list", (10/88) "propagating a new witch-hunt mentality" (2/89). She, said the *LA Times*, "delivers a potentially damaging blow...compar[ing] two [Mapplethorpe] photographs...to child pornography and [saying] none are fit to hang in an art museum" (10/5/90). *Playboy*, (whispering to counsel to the Cincinnati Mapplethorpe trial defense team) reported to its constituency: "I would have taken a .357 Magnum, walked up to her and said, 'Judith, you're history'" (2/91).
