

America's Sex Crisis: Are We at the Crossroads?

Out of the heart ... proceed evil thoughts, adulteries, fornications ... Flee ... Ye are bought with a price...

Mark 7:21, I Cor. 6:18,20

Fifty years ago this year, in 1948, Dr. Alfred Kinsey published Sexual Behavior in the Human Male. Kinsey's "research" totally undermined Bible teachings on sexual morality and America's understanding of courting, love, marriage, birth, and male-female intimacy.

Kinsey's work is the basis of a revolution in porn, homosexuality, criminal laws, and education—all directly affecting children. Dr. Judith Riesman has exposed Kinsey's false "science" in Kinsey, Sex and Fraud and Kinsey, Crimes and Consequences.

Sex obsessed America is at a crossroads. Will the public, will Christians move to reject Kinsey and to restore moral standards?

Kinsey's purpose and methods

When Alfred Kinsey published his first book, the mass media headlined the news that "scientific sex survey methodology" finally measured and reported the truth about the sex life of the average American. America would now be free of the religious hypocrisy that restricted sex to marriage. After all, Kinsey's surveys showed that Americans wore a mask of respectability while they were really engaging in pre-marital sex, adultery, group sex, incest, masturbation, the sodomies, a dozen other perversions and homosexuality.

To those who criticized Kinsey's research data, Kinsey said he merely presented facts. Dr. Albert H. Hobbs from Pennsylvania University said, "no." Dr. Hobbs wrote, in 1948, that anyone who read Kinsey's findings could see that he had two things he wanted to prove, and that he juggled his figures to get what he wanted. Kinsey promoted a hedonistic sex for pleasure, animalistic view of sexual behavior; at the same time he used every opportunity to denounce biblical and traditional moral values and standards of sexual behavior.2 Kinsey's goal was an amoral new order. That new order is possible only if human life is disconnected from God.3

Kinsey's Own Behavior

A recent biographer of Dr. Kinsey, James H. Jones, a Rockefeller grantee and former adviser to the Kinsey Institute, in his book, Alfred Kinsey: A Public/Private Life, 1997, says Kinsey was a sado-masochistic homosexual on a perverted mission. He strolled through homosexual bars and nightclubs, gathering subjects for his research, drawing most of them from those participating in sexual perversions or other criminal acts. He then claimed that those acts were commonplace and natural.

Biographer Jones, writes that in the name of research Kinsey's staff, their wives, and their invited guests performed all kinds of sex acts, some of which were documented continued on page 4

SD WCTU Works to Limit Access to Alcohol in Grocery Stores



SD WCTU is starting a campaign to encourage state government and citizens to work to restrict alcohol displays in grocery and convenience stores.

A recognized goal of Public Health Policy is to seek ways to prevent or alleviate population-wide alcohol problems. The test of a health policy is whether it works. Both national and international research studies show that restricting access to alcohol does prevent social problems including child abuse, crime and driving accidents.

Current SD Law

on film by staff photographers and cameramen. For years these films were made in the attic of his family's home. In a true spirit of sexual harassment, no one remained employed by the Kinsey team who would not give in to Kinsey's demand for sexual revelation and cooperation.4

Kinsey's "Findings"

Kinsey said that his findings showed that people left to their own were naturally bisexual. Religious bigotry and prejudice forced them to focus on heterosexuality and monogamy-or being faithful to one sex partner.5

Kinsey found that all sexual taboos and sex laws were broken so it would be wise to eliminate all laws

He reported that children were sexually active from birth, and that they are never harmed by adult/child sex. What child abuse did he authorize to verify his findings? He claimed children are entitled to so-called sexual outlets, unencumbered by parental miseducation and interference.6

Kinsey said sex can and should be commonly shared with anyone. Adultery and sodomy, he said, were both natural, healthy and acceptable.

Kinsey's findings were a fraud. Neither he nor his team were scientists. They did not use scientific methods and their data was anonymous, forced, and secretly altered at will.7

The First Main Stream Porn Magazine

Hugh Hefner was a college student when he read Kinsey's research. Using Kinsey's new scientific way of thinking about sex to influence college men, he led them to abandon love for sex. Later Hefner, the father of sexual rights, would use his money to help change sex laws, abortion laws, drug laws, and laws about sex eduation in the classroom.

Playboy came out in 1953.

College men liked "recreational sex." The girls next door were transformed into what Kinsey called, "sexual outlets." The effect of porn, says Dr. Riesman, is a homosexual reaction.8

The Homosexual Connection

Harry Hay, a communist. read Kinsey's book and declared his long-time homosexuality. He left his wife and

began the Mattachine Society, the beginning of the political homosexual movement. He became the father of

the Gay Rights Movement.

Normal Relationships Altered

Kinsey's falsified data glorified "sexual satisfaction" as the foundation for marital happiness.9 Divorce rates skyrocketed in the "post-Kinsey" years. Dating relationships changed because "normal" people feared being abnormal if their actions did not agree with Kinsey's findings-taught to them in sex-ed. No-fault divorce, wife swapping, sex therapy as a growth industry, explicit sex in entertainment. -all changed society.

Disease Not Reckoned With

In 1948, the Kinsey Institute team assured the world's readers that "medical techniques which are now available can prevent overall disease from becoming a matter of much social importance."10 Today, sexually transmitted diseases cost taxpayers billions each year. AIDS alone has a human cost too great to fathom.

Legal Consequences of Kinsey's Research

As soon as Kinsey's work was accepted as scientific authority America's common law view of marriage began to crumble. The teaching of the Bible about the sacredness of

marriage and the warnings from Sodom and Gomorrah, the book of Proverbs, and on through the New Testament against fornication and adultery were belittled. All sex was equal as long as it was done between "consenting adults."11

Morris Ernst, an American Civil Liberties Union attorney, with inspiration from

French lawyer Rene Guyon, "sex by eight or else it's too late," planned a legal strategy to bring down America's Judeo Christian

ethics' sex laws. Ernst said in a book he wrote, American Sexual Behavior and the Kinsey Report "virtually every page of the Kinsey report touches on some section of the legal code . . . a reminder that our law falls lamentably short of being based on a knowledge of facts."

At Ernst's recommendation, bar associations formed committees, funded by the Rockefeller foundation, to study Laws on Sexual Behavior and to consider each state's legal system in this field. In 1955 the Model Penal Code from the American Law Institute was submitted to state legislatures with Kinsey's work supporting its passage.

Before Kinsey, rape received the death sentence in three states and life in prison in over 18 states. The new Model Penal Code eventually aided the reduction of penalties for rape, abortion, wife and child battery, desertion, seduction, adultery, prostitution, contributing to the delinquency of a minor, soliciting for masturbation, sodomy, public sexual exhibitions, "unfit" parentage, alienation of affection and obscenity as well as infanticide, premeditated AIDS/STD

transmission of disease, etc.12 At the time the code was being developed, the public wanted a tightening of sexual psychopath laws. But lawyers using Kinsey's findings said a total cleanup of sex offenders would put 95 percent of the male population in jail.

Kinsey died in 1956. A year later the Supreme Court, in a case handled by Ernst, relaxed the legal definition of obscenity. In 1961, Illinois became the first state to repeal its sodomy statute. In 1973, Dr. Mary Calderone, a leading Kinseyan, was cited in the Roe v. Wade decision that legalized abortion. Also in 1973 the American Psychiatric Association removed homosexuality from its list of psychopathologies, and in 1995 pedophilia (adult with child sex) was removed.13

Kinsey's Effect on Education

Since Kinsey found children sexual from birth, sexed that started in college classes worked itself down to high school and then to all grade levels. The Kinsey Institute was back of accreditation for human sexuality teachers so its view of sex reigned supreme.

Obsesssed with Sex

Dr. James F. Kennedy of Coral Ridge Ministries, FL has stated that evolutionist Julian Huxley, when asked why evolution flourished as science, answered, "Because it gave sexual freedom."

Sat. Nov. 21, Rush Limbaugh in an interview on CNN said the country was obsessed with sex, and no one wants others to know what he does.

Anything that obsesses the mind is, according to the Bible, an idol, an object of worship.

Worship of the reproductive faculty, Dr. G. Campbell Morgan, wrote in Crisis of the Christ, 1903, is part of Nature Worship. It is the heart of pagan worship. Worship of sex is rebellion against God. cont. p.5

Continued from p.4 Archeologists who have examined ruins of cities that God ordered Israel to destroy in Canaan have found stones with sex symbols in temple sites. When the kingdoms of Israel and Judah adopted these pagan practices, they in turn were destroyed. Ezekiel 8 in the Bible says they worshipped Tammuz or Bacchus. The worship of Tammuz was celebrated in wild orgies of drunkenness and sex. Halley's Bible Handbook comments, "... the once powerful kingdom . . . sinking lower and lower in the depths of idolatrous infamy, -a stench no longer to be endured in the nostrils of God."

Growing Reaction to Kinsey

Dr. Reisman currently travels world wide to speak, lecture, testify and counsel individuals, organizations, professionals and governments. She and her colleague Eunice Ray have recently established RSVP America —Restore Social Virtue and Purity to America, a strategy to expose the Kinsey fraud and arouse grass-roots concern for change. 14

and convenience stores. During the holidays eye-catching displays include beer and wine in gift baskets. Children, teens, pregnant women, recovering alcoholics and anyone fighting to stay sober, plus drinkers who don't need more temptation, find themselves confronted by alcohol even if they come to buy eggs, bread or milk.

Prayer Leads to Action

The WCTU concern over the prevalence of alcohol displays came to the forefront during an after dinner discussion led by Burdell Nelson at the Rosebud Christian Center. Other WCTU members, Darlene Red Elk Myers, Wayne Dvorak, Jodi Plenty Horse, Muriel and Joan Van Loh added information about SD laws. Guests Harold

and Clarabelle Weller, ranchers from Kadoka, Tina Ludlow, and Delores Espinosa from Mission, SD shared their experiences. Mr. Weller has participated in horseback "Rides for Sobriety" on the reservation. A spontaneous and deeply felt prayer time followed the discussion and led to the decision to write to Mr. Roger Hunt, a SD legislator known for his stand on moral issues.

Rep. Hunt Responds, Advises

On Nov. 12 the WCTU received a letter from state representative Roger Hunt saying that he was willing to sponsor a bill restricting access to alcoholic beverages in grocery stores and convenience stores in SD. Mr. Hunt informed the WCTU that his willingness to act and the success of such a move depends on the forming of a coalition with other groups strong enough to bring pressure

to bear on a majority of legislators. He is interested in a survey of legislators to determine their stand on this issue. Also he would like to be brought up-todate on laws in other states.

SD WCTU is currently taking steps to meet each of Mr. Hunt's requests.

Rep. Hunt's closing statement to WCTU was, "I would like to know exactly what your group's 'game plan' would be. One thing that I have learned, if you don't raise an issue, there will never be legislation to support your position."
