Author Challenges Kinsey Sex Research

Dr. Alfred Kinsey shocked America in 1948 when he released Sexual Behavior in the Human Male, a massive report offering scientific evidence that the sexual habits of Americans were wildly at odds with prevailing moral standards. The impact of his research is such that he is today regarded as the undisputed father of the sexual revolution.

But Kinsey's facts, it now appears, were false. Dr. Judith

in the justreleased book, Kinsey: Crimes and Consequences.

What conclusions did Kinsey reach in Sexual Behavior in the Human Male?

He concluded that 95 percent of American males engaged in some form of sexual offense and that most males engaged in sex prior to marriage. He also said his findings proved that children were sexual from birth—that little infants could be orgasmic—and that sex education ought to begin as early as possible. He said that almost 17 percent of males were engaged in some form of sexual interaction with animals.

What he really was saying was that every sexual value we had in the United States of America up to 1948 was a lieour parents were engaged in illicit, illegal sexual activity. There was no harm that came from that, outside of frustration because they were so inhibited that they didn't tell people what they were doing.

He claimed that if we allowed ourselves to admit all of these things that our parents and grandparents had been doing all along, we would have better marriages in this country. We would have lower rates of venereal disease, fewer out-ofwedlock pregnancies, all our measures of sexual health would increase and our measures of sexual ill health would decrease.

How did America react?

It was above the fold in almost every newspaper in this country. The scientific community largely embraced him. There were some serious critics, but even the most serious of his critics didn't question him as an aberrant person. They were sure that he had tried to do a scientifically valid study. No one could believe that a sexual psychopath could have created this book.

And yet his research was fundamentally flawed?

Well, his research was not just significantly flawed, his research was fraudulent. Fraudulent, meaning that it was purposefully deceitful. He made up numbers.

When we look around us, the sexual psychopathology that radiates everywhere can be seen to be a reflection of Dr. Kinsey.

What do we know about the men he interviewed?

If we even say that he had over 4,000 males, then we know that, at minimum, 86 percent of those men were sexual deviants. We know that he admits to having at least 1,400 sex offenders in his research population. I have identified

just under 1,000, but it certainly could have been significantly more who were homosexuals in the most active sense.

What do we know about Kinsey's own sexual behavior?

He was a compulsive man who engaged in very sexually destructive conduct. He did these things at a very early age. His biographer now has called him a homosexual. This is a man who seduced those around him into these disordered behaviors.

He, by forming the basis of sex education and therapy in the United States of America, by altering our sex laws and public policies—which he absolutely did by shaping the American Law Institute model penal code on sex offenders helped to put us where we are in terms of rape, child rape and in terms of general sexual disorder. When we look around us, the sexual psychopathology that radiates everywhere can be seen to be a reflection of Dr. Kinsey.

The Kinsey Institute has barred you from its archives?

Yes, they certainly have barred me. In fact, they have barred anyone who might in any way be analytical instead of euphoric about what Kinsey has done.

What do you hope to see happen as a consequence of your book?

I would certainly like to see the Kinsey Institute forced to open its doors. I would want to see all that material made available for examination. There is a great deal hidden in there. There is a lot that could come out of this should the American public be [made] aware and become part of the active movement to expose the Kin-

sey research.
