RE: DR. JUDITH REISMAN'S CNP FEBRUARY PRESENTATION

Dear John:

Our fellow CNP member Dr. Judith Reisman is scheduled to speak at the February 2001 meeting in Palm Beach. In their laudatory cover story on her life's work, the *National Review* said Dr. Reisman spent "thirty years uncovering the truth" and consequences of Indiana University zoologist Alfred Kinsey's "Kinsey Reports" (1948-1953). She is looking forward to briefing CNP members on the impact today of The Kinsey Reports and the legal revolution and "Sexual Revolution" (1960s) the Reports ignited. To begin the briefing early and provide some helpful context, I am sending you a mainstream British documentary, "Kinsey's Paedophiles," produced by the International award-winning Yorkshire Television as well as the second edition of Dr. Reisman's revised and expanded book, *Kinsey: Crimes & Consequences (2000)*.

Should you have the time to view the enclosed British Documentary before the February meeting, you will very likely be appalled that The Kinsey Reports reveal close collaboration with pedophiles to conduct sex experiments on infants and children to collect "data." People often say the Kinsey Reports are fifty years old, so why should we care about The Kinsey Reports today? Yes, they agree we should find "The Children of Table 34" molested for the Reports and see that they receive help, but otherwise this fraudulent and criminally derived research doesn't touch anyone today. Yet, in 1998, to signal their continuing importance, Indiana University Press republished both Kinsey Reports without apology. Dr. Reisman will document for CNP that, in fact, The Kinsey Reports have remained viable since the 1950s and how the Kinsey canon has more impact today on our laws, public policy and funding than when Kinsey was alive.

My wife Eunice and I have worked with Dr. Reisman since the early 1990s. I have acted as a legal advisor to Dr. Reisman as she uncovered the covert and undemocratic changes brought about in American law in every state based on Kinsey's fraudulent "sex science." To publish Dr. Reisman's work, Eunice developed the *RSVP America* Campaign (1998-2003) to coincide with the 50<sup>th</sup> anniversary of the publication of The Kinsey Reports. The mission of the campaign is to expose The Kinsey Reports' enormous and pernicious impact on America's institutions, particularly of law, education and medicine.

Eunice has assisted with privately funding the distribution of the first and second editions of Dr. Reisman's book, which is more than great history and a compelling read: It is also a weapon. After 50

years of media deception – the promotion of Kinsey and his Reports as objective science, elite leaders in law, medicine, and education, aided by government programs and tax dollars, have used The Kinsey Reports as the authority for revolutionary changes in many of America’s pre-1948 laws which had largely served to protect marriage, women and children. Dr. Reisman’s findings can be and have been used successfully to check further use of the Kinsey Reports as science to halt an “inevitable” march through our institutions.

Admiral Thomas H. Moorer, USN (Ret.), former Chairman, Joint Chiefs of Staff, with whom Dr. Reisman and I have worked in stopping Kinsey’s use in dismantling America’s military institution, well understands how vital it is to defend America from her enemies, both foreign and domestic. The Admiral wrote of her and her book that:

Dr. Reisman’s *Kinsey: Crimes & Consequences*, is “must reading” for every American who wants to understand the “demoralization” of our nation. She is a scholar of international renown who brings courage, integrity, tenacity and profound insight to her world-class research and writing, sorely needed in America where powerful special interests often distort the truth for financial gain or unconstitutional political ends. Her important work has been successfully presented to Congress, the U.S. Supreme Court, a Presidential Commission, many Executive Branch Departments, and to members of the Joint Chiefs of Staff.<sup>1</sup>

Her discoveries began in 1981, when Dr. Reisman found that Kinsey’s “scientific” Reports contain a record of the systematic sexual abuse of infants and little boys by pedophiles collaborating with Indiana University’s Kinsey Institute at Bloomington, Indiana. Based on data that contained pedophile-child sex experiments, The Kinsey Reports claimed to PROVE that for the first time, humankind was naturally bi-sexual and had sexual capacity and erotic desire, from birth. Further, Dr. Reisman discovered that these influential sex Reports were not “scientific,” as has been represented for fifty years by Indiana University and the elite media. In reality, Kinsey was never the “conventional” unbiased scientist, but rather in 1997, he was revealed to be a sado-masochistic bi/homosexual “covert crusader” seeking to “free” Man from any legal, moral and biological design constraints put upon his sexual conduct.

Dr. Reisman painstakingly documents that the Kinsey Reports methodology and statistics are totally false. This was well known by the IU Institute’s financial supporters prior to publication of the first Kinsey Report in 1948. Allan Wallis, past President of the American Statistical Association and past Editor of the *Journal of the American Statistical Association*, who first looked at the Kinsey Reports in the 1940s, said of Dr. Reisman’s statistical investigation of the Kinsey Reports that;

Kinsey does, to be sure, scatter bits of information... no one previously [to Dr. Reisman] has done the painstaking work of pulling the bits and pieces together and estimating the proportion of respondents... your figure of “roughly 86%,” [deviant male subjects] it does appear to be in the right ball park; but even if the correct figure were only a quarter of that the effect on Kinsey’s validity would be devastating.

Since 1948, a well-coordinated legal revolution using the Kinsey Reports as new “science” has been conducted in every state. To spur these revolutionary changes to law, influential books were published in tandem with the Kinsey’s *Sexual Behavior in the Human Male* in 1948, which heralded the elite media call for “science-based” sex law reform grounded in Kinsey’s data. These books were written by the day’s leading legal, scholarly and scientific authorities with assistance from IU’s Kinsey Institute:

- Lawyer, Morris Ernst, ACLU co-founder, Kinsey's lawyer and long time lawyer to Margaret Sanger published *American Sexual Behavior and the Kinsey Report* (1948). Prior to 1948, state laws prohibited all sexual contact except marital intercourse. Ernst wrote of the import of the Kinsey Reports saying;
  - [R]ecently, law has reached for scientific tools to aid in its search for truth. Fingerprinting proofs, heredity blood tests, lie detectors...the Kinsey report is the single greatest contribution of science to the rule making part of the law in my lifetime [more than] the Brandeis Brief.

  - Albert Deutsch published *Sexual Habits of American Men, a Symposium on the Kinsey Report*. This book was a collection of essays and opinions written to encourage abandonment of American laws. Decades before the feminist movement was begun, the lawyers citing the Kinsey canon attacked legal "favoritism" toward the American sanctity of marriage, and legal protections for women, children and the family. No-fault divorce was launched which led to single mothers in poverty and satellite social decline. Albert Deutsch writing in *Look*, May 1951, said;
    - The figures published in the first Kinsey Reports have already been ritualized as standard ammunition for pro and con arguments in court cases involving questions of sexual behavior, or misbehavior.
  - Rene Guyon, of "sex before eight or it's too late" fame and a French jurist, an acknowledged pedophile and Justice of the Supreme Court of Thailand, published *The Ethics of Sexual Acts* (1948). Guyon wrote ten books in a series advocating total abolition of all laws restricting "sexual freedom." Guyon corresponded with Kinsey and both argued for sympathetic treatment of sex offenders, rapists, and pedophiles.

Today, it is important for leaders and public officials to understand that using The Kinsey Reports' junk science as the authority, American law was liberalized and once vigilant public values and attitudes were relaxed. Chapter eight of Dr. Reisman's book presents a survey of the legal revolution accomplished, in significant part, through the American Law Institute's Model Penal Code (MPC). The MPC was used as the guide to "revise" or "reform" the criminal codes of most states. The MPC, over time, has eroded the strong criminal and legal protections for marriage, the institution whose primary beneficiaries are women and children. The MPC, adopted entirely or in part in all states worked to:

- Abolish or weaken American Common Law (built on the principles of the Old and New Testaments) that firmly penalized rape, wife/child battery, incest, sodomy, etc.
- Abolish or weaken the Common Law that prohibited adultery, fornication, cohabitation, seduction, prostitution, etc.
- Abolish or weaken obscenity laws, facilitating its development as a billion dollar media/sexuality industry called "pornography" or "erotica" distributed worldwide and nationwide to adults and children in civil and military society.<sup>1</sup>

In 1968, Manfred Guttmacher reported that in the mid-1920s, the ALI sought funds from The Rockefeller Foundation to carry out a legal "codification project" but they were counseled to hold off because "the behavioral sciences were on the ... threshold of be[ing] of great assistance." In 1950 the American Law Institute, now with Rockefeller funding, began the task of writing a Model Penal Code. When the first draft was completed in 1955, the new Code was presented to state legislators as common

law reform based on new “scientific” insights. The MPC “abolished”<sup>2</sup> the common law, which included the general principles of primitive Christianity.

So troubling were the winds of undemocratic change being funded by the big tax-exempt Foundations, that in 1954, a Congressional Committee investigating the large Foundations and the projects they funded found after investigation that:

**The [Rockefeller] Foundation sponsored “Kinsey report was deliberately designed as an attack on Judaic-Christian morality.”<sup>3</sup>**


The good news is Dr. Reisman’s findings about Kinsey, his widely promoted Reports, his colleagues and professional disciples in the American field of human sexuality (which was created by and rests totally on the “findings” in the Kinsey Reports) are being presented to public officials via the *RSVP America* Campaign. Campaign leaders have until 2003, the anniversary of *Sexual Behavior in the Human Female*, to discredit and debunk the Kinsey Reports by presenting the truth about the Reports to church groups, teachers, school board members, doctors, nurses, state legislators, judges, etc.

The *RSVP America* Campaign has materials and information helpful to any pro-life or pro-family group aggressively working to restore the pre-Kinsey virtues of modesty and chastity and strengthen the institution of marriage. In the initial phase of the *RSVP* Campaign, the discrediting phase, parents were alerted that their children are receiving false claims about behavior and life based on Kinsey’s junk science in their sex-ed classes. Parents have been informed and warned by presentations; CDs and printed materials about The Kinsey Reports that promote “free love;” that “safe sex” can have no hurtful consequences; that children are not capable of self-government and can’t help themselves but are going to do “it;” that children need sexual instruction in early grades because they are sexual from birth and need and have a right to know everything about sex. These are all misrepresentations based on fraudulent and criminally derived data.

But in order for Kinsey-based sex-education to come into the schools, state criminal laws had to be changed. For example, in Missouri as late as 1971 it was unlawful to talk to a person under 21 years of age about “sexual intercourse”. It is difficult to present “AIDS Prevention” (sodomy instruction) in schools, when such discussion is illegal. We all must understand that the Kinsey canon has been the basis for radical changes in laws and policies that now mandate teaching sexual perversions to American schoolchildren.

Dr. Reisman is looking forward to briefing you in Palm Beach on the current influence of The Kinsey Report and related fraud on American life and on what the *RSVP America* Campaign is doing. The Campaign’s ultimate goal is to inform and call upon others to act to restore some of the laws which have been changed based on Kinsey’s junk science. With this daunting task accomplished, the law will once again teach and point the way to protecting American women and children. We look forward to seeing you in Florida.
