## **Jury urges 40-year sentence** in kidnap, sex assault of girl

A Jefferson Circuit Court jury yesterday recommended that James D. Gustin be sen-tenced to 40 years in prison for kidnapping a 6-year-old girl and sexually abusing and sodomizing her last August

The jury could have rec-ommended that he serve 85 years.

years. Outside the courtroom, his lawyer, Bart Adams, said: "It could've been a lot worse. I think the jury realized that Mr. Gustin knew what he did was wrong and wants to get help." But his problems might not be limited to Jefferson County:

Gustin, 37, is a suspect in Gustin, 37, is a suspect in a case in Florida involving a 9-year-old girl who was kid-napped and sexually assault-ed, said Louisville police Sgt. Lynn Hunt. Hunt, who was the lead detective in the case in Lou-isville said a Florida court

isville, said a Florida court ordered Gustin to provide a blood sample for DNA test-

ing. According to an affidavit filed in that case, the St. Johns County Sheriff's Of-fice in St. Augustine is in-

vestigating a case that is similar to the Louisville case. On Sept. 24, 1996, a girl was kidnapped in St. Augustine by a man who may have been driving a car with Ohio plates. The girl was sexually assaulted and let go Gustin is from

was sexually assaulted and let go. Gustin is from Springdale, Ohio. The case detective in the St. Johns County Sheriff's office could not be reached for comment yesterday. Ad-ams could not be reached for comment on the Florida for comment on the Florida case

Gustin is scheduled to be sentenced in Jefferson County on April 9 by Circuit Judge Stephen Mershon. Ingrid Geiser, one of the assistant commonwealth's attorneys who prosecuted Gustin, said she was "some-what disappointed" by the jury's decision to recom-mend only the minimum penalty on the sodomy count. However, she called it a "just verdict." Gustin admitted to kid-napping the girl, who is now 7, after driving by her house and seeing her playing in

and seeing her playing in the front yard. He took her to various places in Louis-ville, where he stopped and sexually assaulted her, then let her go. He has denied

committing sodomy. Testifying for Gustin in the sentencing stage of his trial, Michael E. Darrow, a trial, Michael E. Darrow, a licensed clinical social work-er who specializes in treat-ing men who sexually abuse children, said Gustin told him he was molested by a baby sitter when he was 7 and 8 years old. Darrow said he was not trying to justify what Gustin did, but simply trying to help explain where "this came from." Darrow said Gustin has a problem with sexual addic-

problem with sexual addic-

tion and has "little or no awareness of the impact of his conduct on other peo-ple" ple

Adams told the jury that Gustin needs to be held ac-countable for his actions but

countable for his actions but asked jurors to show mercy in sentencing him. "You saw what a pitiful human being he is," Adams said, referring to the several times that Gustin broke down crying when he took the stand and testified in his own defense. Gustin told the own defense. Gustin told the jury he was "very ashamed" of what he'd done.

In her closing argument, Geiser focused on the sod-omy count, which carries the toughest rules on parole eligibility. Gustin faced 20 to 50 veges in pricon for sodomy

Gustin faced 20 to 50 years in prison for sodomy, and the jury recommended the minimum 20, which means he would be eligible for parole after serving 17 years, or 85 percent of that sentence. The jury also rec-ommended he serve the maximum 20 years for kid-napping, and five years on each count of sexual abuse. The jury recommended that The jury recommended that only the 20-year terms for sodomy and kidnapping run consecutively, for a total of 40 years.
