KINSEY: DEPRAVED CRIMINAL PERVERT

Later this year, a strange legal case brought by a 21 year old prison inmate against a New York psychiatrist, will come to trial in Federal District Court in Bridgeport, Connecticut. The inmate, Denny Almonte is suing psychiatrist Dr. Douglas H. Ingram because when Denny was 10 years old



he had been sexually molested by Dr. Joseph De Masi, child psychiatrist and pedophile. Dr. Ingram is being sued because as Dr. De Masi's professor at the New York Medical College he had learned that De Masi was a pedophile but did not take steps to stop De Masi's career.

Almonte, who is serving a five year term for assault, told *The New York Times* (4-19-98) that rage built steadily inside him after his appointments with Dr. De Masi. He said that when De Masi would pin his hands behind him and rub his groin against his buttocks, "I felt really disgusting. I felt nasty. It changed me so much. I still don't feel like me. I don't know who the hell I am sometimes." It is a story oft repeated — in later life, many of the victims of pedophilia become victimizers or prostitutes or drug addicts.

However the late Dr. Alfred Kinsey disagreed with those conclusions and he set out to "prove" that his warped views of sexual perversion were normal.

In *Kinsey: Crimes & Consequences*, author Dr. Judith A. Reisman exposes Kinsey and

the Kinsey Institute at Indiana University as the perpetrators of a criminal hoax so monumental that it is still doing irreparable damage to the moral values of America.

In chapter 4 "Stag Films as Sex Research at Indiana University" Dr. Reisman writes, "Kinsey was openly disdainful of other famous sex researchers as too conventional...Kinsey was 'appalled' to read that Freud treated masturbation, an activity which preoccupied Kinsey, as a sign of immaturity, even sickness. Freud also acknowledged that children have a 'latency' period during which sexual disturbance or stimuli is harmful to them. For these reasons, it seems, Kinsey held Freud in contempt."

Kinsey and his team of sex researchers filmed perverted sexual activity. "Mrs. Kinsey was a participant [in group sex] allowing herself to be filmed masturbating and engaged in varied forms of sex with Kinsey's young co-authors and assistants," writes Dr. Reisman. She reveals that "Kinsey and his team also collected films of children engaged in sex acts, a fact confirmed in 1981 by Kinsey's co-author Paul Gebhard: 'Since sexual experimentation with human infants and children is illegal, we have had to depend upon other sources of data. Some of these were parents... A few were nursery school owners or teachers. Others were homosexual males interested in older, but still pre-pubertal children. One was a man who had numerous sexual contacts with male and female infants and children, and being of a scientific bent, kept detailed records of each encounter. Some of these sources have added to their written or verbal reports photographs and, in a few instances, cinema...The technique involved [included] adult-child contacts - chiefly manual or oral.'" (Kinsey received substantial funding from the Rockefeller Foundation for his faulty research.)

Dr. Reisman states, "That the Kinsey team permitted and may have even filmed criminal sexual abuse of infants and children, is based largely upon their own writings, interests, and reports and the suspect credibility of Kinsey and his team." At least 317 infants and young children were sexually abused for Kinsey's 1948 report!

Kinsey's films of coitus, sodomy and sadistic sex scenes were recommended for medical students. Reisman writes, "Not only did Kinsey's obscenity training impact upon the medical profession and the dignity and respect for life in health care circles, it changed the law and the legal profession as well. It compromised medical doctors..." As an example, Reisman cites Dr. John Money of Johns Hopkins University who introduced "obscenity into medical training...[Money] writes of the need to legalize sex with children in the pseudo academic *Journal of Pedophilia*."

In *The Pied Piper of Sex*, author Dr. Vernon Mark, Harvard Medical School professor wrote "Kinsey seems to have provided the impetus for showing sex movies to medical students and in 1967... professor John Money compiled an illustrated presentation called 'Pornography in the Home,' which became very popular with students at Johns Hopkins Medical School. Since Johns Hopkins enjoys a leadership role among American medical colleges, it is not surprising that [roughly 90% of] medical schools followed its lead in initiating explicitly sexual films as part of the curriculum."

Denny Almonte might well consider adding the Kinsey Institute to his law suit against Dr. Ingram and the New York Medical College.
