## Rape of a sacred trust

How pedophiles  
have targeted the  
Boy Scouts of America

Indeed, one of the very high-profile homosexuals of this generation is former Rep. Robert Bauman, the powerful conservative congressman who was in line to become speaker of the House. In his autobiographical book, "The Gentleman from Maryland: The Conscience of a Gay Conservative," Bauman revealed that at the age of about five, he was seduced by an older neighbor boy.

It was his first sexual experience.

Reflecting on that, as well as subsequent similar episodes, Bauman describes the powerful feelings he found welling up within him at a young age:

"This was not a matter of chance attraction to a forbidden object. This was a frightening force from deep within my being, an involuntary reaction to the sight, smell, and feel of other boys. I neither understood nor accepted it, and I came to hate myself because of the presence within me of this horrible weakness, this uncleanness of spirit over which I seemed to have no control."

The country was stunned in 1980 when headlines revealed that Bauman, the powerful ultra-conservative congressman from Maryland, was a homosexual, having had a sexual rendezvous with a young male prostitute.

Forcibly "outed" in this way, his tortured double life exposed, he lost his job, his family and his historic home. In an effort to try to put the pieces of his life together, he wrote his book.

"I didn't choose to be homosexual," he writes poignantly. "I would change my sexual orientation if that were within my power."

Changing sexual orientation? Ironically, perhaps the best-kept secret in the homosexual cultural-political debate - and certainly the arena that inspires the most vitriolic response from homosexual activists - is the ex-gay movement. The very existence of therapy and counseling services dedicated to helping homosexuals leave that lifestyle is being attacked as "hate-speech," lies and worse. Yet, there are many organizations, most of them from a religious orientation, that have successfully helped countless homosexuals and lesbians who are unhappy with the lifestyle.

Meanwhile, the Boy Scouts of America, nearly a century old, remains one of the most loved and revered organizations in the nation's history. Sixty-three percent of U.S. Air Force Academy graduates were Boy Scouts; 68 percent of West Point graduates and 70 percent of Annapolis graduates were Boy Scouts; 85 percent of FBI agents were Scouts; 85 percent of student council presidents and 89 percent of senior class presidents were Scouts; and 26 of first 29 astronauts were Scouts.

So, while it is being attacked from without, as recent news stories document - and from within, as this report attests - the Boy Scouts of America has an unassailable record of helping generations of American boys to grow up to be "physically strong, mentally alert, and morally straight."

## *World's most famous child molester*

Meanwhile, there is no scientific or biological evidence that people are born homosexual, said Reisman. In fact, she said, National Research Council adviser and Kinsey researcher John Gagnon advised sex researchers to "hide the causes of homosexuality."

"The wish of some gay men and lesbians to locate the origins for their desires in ... biology or early experience deserves a respectful response even though I think it to be wrong," said Gagnon.

Reisman places the blame for the homosexual agenda squarely on Kinsey's 1948 report, which she calls "a vast and meticulously orchestrated media-relations campaign." Indeed, the report made Kinsey a folk hero in the major publications of the time, including *Life*, *Look* and *Time* magazines.

Trained as a zoologist, Kinsey reported that Americans only pretended to be virginal, monogamous and faithful heterosexuals. Rather, he claimed, the vast majority of Americans are by nature hypocritical, promiscuous, closeted bisexual or homosexual adventurers, said Reisman.

The press went along with this view and failed to investigate or report what is now, decades later, indisputable fact - that Kinsey and his researchers were sexual deviants.

James Jones, in "Alfred C. Kinsey: A Public/Private Life" concurs with Reisman, as does Jonathan Gathorne-Hardy in his book, "Sex, the Measure of All Things."

Relying on research provided by Jones and Gathorne-Hardy, Reisman said, "Kinsey's most recent admiring biographers confessed that he was a sadistic bi/homosexual who seduced his male students and coerced his wife, his staff and their wives to perform for and with him in illegal pornographic films."

Supported by various documents in her research, Reisman claims that Kinsey and his team - including Wardell Pomeroy, Clyde Martin and Paul Gebhard - were married only for appearances.

Kinsey's perversions eventually led to his death. Jones and Gathorne-Hardy report that Kinsey died of orchitis, a lethal infection of the testicles caused by years of "sadistic, orgiastic self-abuse," noted Reisman.

Although a number of other studies have now exposed flaws in the Kinsey report, the establishment press has largely failed to report those findings.

The raw truth of what Kinsey actually did, warns Reisman, is almost beyond belief.

"Kinsey solicited and encouraged pedophiles - at home and abroad - to sexually violate from 317 to 2,035 infants and children for his alleged data on normal 'child sexuality.' Many of the crimes against children (oral and anal sodomy, genital intercourse and manual abuse) committed for Kinsey's data are quantified in his own graphs and charts," Reisman stated in her report and reiterated to WorldNet.

"For example, Table 34 on page 181 of Kinsey's 'Male' volume, claims to be a 'scientific' record of 'multiple orgasm in pre-adolescent males.' Here, infants as young as 5 months are timed with a stopwatch for 'orgasm' by Kinsey's 'technically trained' aides, with one 4-year-old tested 24-hours around the clock for an alleged 26 orgasms. Sex educators, pedophiles and their advocates, to prove children's innate need for sexual satisfaction, commonly quote these child 'data.' The claim of a legitimate need by children for a satisfactory sexual life results ultimately in the teaching of 'safe sex,' inclusive of all forms of 'sexual orientation,' homosexual, heterosexual, bisexual, etc., via school sex education," said Reisman.

She was critical of the media for failing to question how Kinsey conducted his research.

"Kinsey defined 'screaming,' 'writhing in pain,' 'fainting,' 'convulsions,' etc., as 'orgasms' for infants too young to speak," explained Reisman, quoting from the Kinsey report itself.

Reporters in 1948 and since have failed to ask important questions, says Reisman. "Who sexually tested these infants and children? Where were the parents?"

## *Epilogue*

The tragedy of childhood seduction is followed too often - though obviously not always - by the victim being drawn into the lifestyle of the seducer, and ultimately becoming a victimizer himself. The pattern is all too familiar to researchers who witness the inheritance of disfunctionality from one generation to the next, whether it be alcoholism, violence in the home, or sexual addiction.

"Losing is not part of the plan," said Abrams, referring to homosexual activists' long-term strategy. "Every time they lose, they just regroup and push ahead in some other way or use some other method. They slowly erode and slowly corrupt any opposition to their agenda."

### *Web of seduction*

The Internet offers significant evidence that homosexuals actively seek young boys as sexual partners - and that they specifically target Boy Scouts.

WorldNet searched for and easily found over 100 websites containing pictures of boys in scout uniforms, including boys in various states of undress, intended to titillate viewers. Many of the sites are located in foreign countries where laws are less restrictive. Some feature games that enable visitors to strip clothes off pictures of boys. One enables viewers to travel from house to house in an imaginary city and have fantasy sexual experiences with boys of various ages.

Some websites contain narrative accounts of sexual experiences with boys - including many describing sexual encounters that occurred on Boy Scout camping trips. The narratives describe a full range of homosexual acts between adult men and boys as well as between boys - all depicted as consensual. But the seduction and enticement used to gain consent from the boys is clearly evident.

Reisman and Abrams agreed the accounts are accurate as to the manner in which boys are enticed to participate in sexual activity. Most boys are made to feel they cannot reveal what happened out of fear of getting into trouble for their actions.

A large number of "boy lovers" websites were found as well. Many homosexual men prefer sex with boys, particularly young boys, and have created websites containing pictures of boys and editorials providing justifications for their actions and rationale why sex between a grown man and a young boy should be legalized.

One website offers advice on how adult men can volunteer as a leader for various youth groups to gain access to young boys. The site provides disclaimers that it does not condone or recommend that adults have sex with boys, but after the disclaimer, the rest of the site clearly describes how readers can arrange to have sex with boys.

The site lists organizations that readers should consider for potential sex with young boys. Some of those organizations include:

- Big Brothers/Big Sisters of America
- Boy Scouts of America
- Gay, Lesbian, and Straight Education Network
- Little League
- Multi-Agency Adoption Resource Center
- Pattaya Street Kids Crisis Center
- Lesbian, Gay, and Bisexual Adoption Sites
- Young Marines

Many of these sites claim that "boy lovers" provide better "real love" to boys than do their own parents. One such site includes a "Boy Lover Code of Ethics."

"Gay men view these boys as recreational toys to be used. I have heard many stories of HIV positive men having unprotected sex with boys. They don't think it matters," revealed one homosexual activist in "The Advocate," a homosexual newspaper in March 1992.

That attitude, said Reisman is all too common in the homosexual world, although never expressed in the news media. Indeed, the mainstream press routinely employs homosexuals or bisexuals to cover stories dealing with sexual orientation "further compromising the public's ability to obtain unbiased reports," she said.

According to Robin Lloyd, author of "For Money or Love," the press suppresses police reports of raids and arrests of adults preying on young boys.

"Both wire services, the Associated Press and United Press International, file the stories to their clients (media outlets), but the stories are always preceded with the cautionary 'EDITORS (NOTE NATURE OF THE STORY).' Editors do, ... and often elect not to use them," said Lloyd in his book.

The influence of homosexuals in the news media is so strong today that at last month's 10<sup>th</sup> annual conference of the National Lesbian and Gay Journalists Association, a vice president of NBC and a national correspondent for CBS led a panel discussion, both advocating the view that the news media, in the future, should not dignify anti-homosexual viewpoints by even including them as dissenting voices in stories dealing with homosexual themes.

Older teens and adult men are taking advantage of the natural curiosity of young boys between 10 and 14, said Reisman. Many homosexuals claim boys who have homosexual sex at that age are demonstrating their predisposition toward homosexuality. Rather, said Reisman, they are simply taking advantage of an opportunity to satisfy their youthful curiosity. Once exposed to homosexual sex, however, many boys will continue to engage in sexual play and experimentation with each other and with older partners. Repeated experiences create a form of conditioning, and eventually those boys will believe they are homosexuals - that they were "born that way," said Reisman.

"There's just no data to suggest that this is a genetic pattern. If you believe in creation, you know they're not born that way. God didn't do that," she said. "If you're a person who believes in evolution, you're between a rock and a hard place, because ... this is a group that does not reproduce. End of story."

The tragic and well-known cycle that often ensues is that as molested boys grow older, they may begin to seek as sexual partners boys who are younger than they are, beginning the cycle again. Many boys become conditioned to seek sexual adventures while camping because that is where they have had many of their previous experiences, said Reisman. Each time they go camping in a tent with other boys, they are conditioned to look for sexual gratification. When they become adults, they volunteer as a scoutmaster because it brings them back to the origins of their own first sexual activities. In exactly this way, she said, many older boys and men seek sex with young boys to relive the sexual adventures they once had as a boy.

"It's a vulnerable time in their lives, and it's a vulnerable time in our lives in terms of society," she said. "When have we ever been telling children in the class-

room, 'Hey, this is perfectly normal. You should experience this and go out and try it'? When have we ever shown children films, given them books, all telling them, 'This is all perfectly all right. Your parents are the uptight people keeping you from this normal experience'? And then you go put them out there in the scouting environment.

"When there are a few boys in there who have been using pornography or who have been abused, they start to tempt and titillate very innocent young boys who are interested in everything. They're interested in how a truck fits together. They're interested in how the body fits together and how it works. So they nail them at that particular time. And once that happens to a boy, he's in big trouble," said Reisman.

When the boys go back to public school, they receive more reinforcement that the experience they had in the tent was normal and OK, she added. If boys mention their experience to a school counselor, they are sent to a group of boys who

have reported similar experiences so they can learn to "come out." School counselors rarely inform parents about what has happened, and there are no reports of school counselors who attempt to persuade sexually molested boys that they need help to protect their heterosexual identity, said Reisman.

"When you start tampering with a boy's sexuality - his manhood - you are sending him into a path that is extremely difficult for him ever to move out of. He thinks that he brought this on himself. These boys all think that," she added.

Despite the recent setbacks for the powerful homosexual activist movement - the Supreme Court ruling in favor of the Scouts, the lopsided congressional vote supporting BSA, the unwillingness of most corporate donors, despite intense pressure, to drop their funding - the attack on the Scouts will not stop.

recent, widely publicized event at Tufts University in which youths as young as 14 were taught the finer points of "fisting" and other homosexual practices - by Massachusetts state employees - is typical. That particular event was "outed" and its participants rebuked only because a "mole" critical of the program attended it and taped the entire event, subsequently making the tape available to the news media.

The media, however, never bothered to check Kinsey's methods or his data, says Reisman. And the burgeoning homosexual-rights movement, flexing its newfound muscle, used the Kinsey report as a battering ram to knock down society's traditional condemnation of homosexual behavior.

"They simply continued, with the support of the media, to repeat and to desensitize [the public] over and over and over again, until finally, at a certain point, people believed what they were being told," said Reisman. "Middle America never applied [the Kinsey report] to themselves, but their kids did. The kids believed it, and the kids believe it about their parents.

"It happened in the '60s when the younger generation talked about their parents being a bunch of hypocrites, because allegedly their parents engaged in all these sexual peccadilloes. See, the children went to college and their professors told them, and of course, the professors were engaged in such sexual peccadilloes. So Mom and Dad got smeared with the same brush. The American public came to believe Kinsey because all the authorities were saying this was true. It took on a life of its own once it got underway," said Reisman.

The homosexual activist movement's strategy, she says, is classic - basically, that if you repeat a lie often enough, people will end up believing it. Repeat often enough that an apple is an orange, and sooner or later people will not only believe that an apple is an orange, but will argue the point and help persuade others to the same viewpoint.

"It took 50 years," Reisman concluded, "but here we are."

This public relations campaign, however, is now much more refined than in the past, says Kevin Abrams, co-author of "Pink Swastika."

"The gay-rights movement is basically a very well-orchestrated program of public engineering or social

engineering," he said. "After the Ball' is a book that documents the program to engineer public acceptance of homosexuality, and it hides the more militant form. This apparently harmless image of effeminate gays hides the threat and danger of the more violent and predatory form of pederastic gay militancy riding in on the coattails of the apparently harmless image that people see in the public media. There's actually a dark underbelly to the whole issue that is largely unseen by the general public."

### *Schools set the stage*

Scout leaders who are disposed toward molesting boys have little difficulty in accomplishing this aim on Scout trips and keeping their activity quiet. Why?

Boys most often sought after by molesters are 11 to 14, the typical age of most Boy Scouts. Some school programs teach boys at that age actually to consider the possibility that they are homosexuals, and some go so far as to say or imply that the boys should experiment with masturbation alone and with friends. Their parents don't understand - that's the clear implication - and therefore they should not talk to them about it.

Once the stage is set in school, said Reisman, Boy Scout camping trips provide an opportunity to carry out the recommended experimentation. Under such circumstances, it is not surprising that a great deal of homosexual molestation of boys goes unreported, she added.

"What you have is early sex abuse as a very viable, real part of what is turning kids into homosexuals. And that's something the homosexual movement is fighting tooth and nail to keep from the public. People knew that about 30 years ago, before the massive publicity. Even Kinsey admitted that in his book 'Sexual Behavior in the Human Male.' He admitted that. He admitted that the first person you have a sex experience with is really going to determine where you're going to go," explained Reisman.

### *Kinsey's plague*

"Kinsey fathered a network of Kinsey clones called sexologists that spread through the land like a plague," said Abrams. "They've indoctrinated everybody into thinking that this kind of sexual liberation is a kind of freedom, but it's a freedom that leads to total annihilation. It leads to sexual, emotional and spiritual bondage."

"Each incident (of abuse) took place when the leaders were not trained or the rules weren't followed," he said.

Despite the BSA training and rules, the incidents of reported child molestation have been on the rise. The scouting organization attributes the increase to greater awareness because of the training given to boys and to a record number of boys in the program - about 5 million. BSA statistics and various media reports over the past 20 years show a near-tripling of sexual abuse cases - from about 70 cases a year then to about 200 annually now.

Reisman expressed concern that the BSA rules may not go far enough.

The ideal situation, she said, is for fathers to go on camping trips with their sons. Fathers should stay in tents with their own sons, and boys who are not related to them should not sleep in their tent. She recognized, however, that not all boys have a father to go with them.

She also advised that young, single men should never be permitted to camp with boys, but that it would be ideal, rather, if leaders are married and have children participating in the program.

### *The 'helping band'*

In Gilbert Herdt's book, "Gay and Lesbian Youth," Douglas Feldman, a medical anthropologist and a member of the homosexual activist community, is quoted as saying, "These kids are our future and we must invest in them." Feldman states that teen-agers are "very susceptible to sexually transmitted diseases," and that sexually abused boys "have about a 1 in 4 chance of developing AIDS in approximately five years."

Herdt speaks of adult male homosexuals as "coaches" and "guides" who should help young boys overcome their heterosexual "victim" status by "coming out" into homosexuality.

Reisman blames the nation's public schools and lawmakers for granting various protections to such "coaches" and "guides" within the nation's schools.

"They teach confused children about tolerance, sexual diversity and such. They like to tell young boys that 'at least one in 10 of you are gay.' Anyone who objects is immediately labeled homophobic," she said.

In his study, "The Role of Adult Advisors" (as quoted from Herdt's "Gay Culture in America"), homosexual advocate Frederick Lynch says, "What has not been brought out fully in some other coming-out studies is the role of the guide, teacher or 'helping hand' in either the signification state, the coming-out stage or both ... the often benign and helpful role that older, more experienced homosexual men play with regard to younger (males)."

Reisman is concerned that educators have embraced the homosexual agenda and now encourage boys to have sex with each other at an early age. One of the places such experimentation could easily take place is in a tent during a Boy Scout camping trip, she said. Boys who have been told that experimentation is acceptable may also be willing to accept the advances of an adult male or older boy, she added.

"They tell these impressionable kids that if they feel different, confused, strange, or if they are questioning, that they may be gay," she said. "What child isn't confused at that age, anyway? These kids don't know what to think, and then they're told it's OK to experiment to find out."

### *Project 10*

School programs like "Project 10" - a nationally used public school curriculum which teaches students that 1 out of every 10 children is a homosexual - serve as a catalyst for the seduction and homosexual recruitment of young people, claims Reisman. She adamantly disputes the 1 in 10 claim, as do many other researchers. But she goes much further: Reisman blames the press for not exposing what she says is the core deception, one that began with "Sexual Behavior in the Human Male" by Alfred Kinsey in 1948.

The text given to teens in the "Project 10" program is "One Teenager in 10." Reisman found that 38 percent of the short stories used in the text describe sexual activity between children and adults. One story begins:

"I have been a lesbian since I was 12. I had known my dance teacher for three years before she brought me out."

The claims made in the 1948 Kinsey report - principally the claim that 1 in 10 people is homosexual - have been used ever since both to legitimize homosexuality and to justify what increasingly amounts to open near-recruitment in the nation's schools. The

An uncertain percentage of the estimated 2 million homosexual men victimized 6-8 million boys, age 18 or younger, amounting to 17 - 24 percent of all boys.

Therefore, considered in the aggregate, 3 - 4 boys are sexually molested per homosexual adult male.

Only .09 girls are sexually molested per heterosexual adult male, which is to say that, on average, 1 in 11 heterosexual males victimizes a girl under 18.

Within the child protection establishment, sexual abuse is defined simply as an adult having sexual contact with a youth age 18 or under - whether "consensual" or not. When dealing with children, "consensual" is not the legitimizing criterion it is for adults. Indeed, almost invariably, sexual predators defend their "loving" physical relationships with children as being "consensual," when in reality the seduction and manipulation of children - resulting in their "consent" - is both an art form and the stock in trade of pedophiles.

The Simon and Schuster book "Homosexualities," by Alan Bell, reports that 25 percent of homosexual men admit to having had sex with boys who are 16 or under.

Further corroborating this well-hidden homosexual proclivity for targeting younger males are the following findings published in the Journal of the American Medical Association: 50 percent of male AIDS victims reported having sex with an adult male by the age of 16, and 20 percent of male AIDS victims had sex with an adult male by age 10.

"The Advocate," a popular homosexual newsmagazine, conducted a survey of its readers. Of the 2,500 responses obtained, 21 percent admitted that an adult man committed a sexual act with them by the time they were 15.

### ***'The ideal situation'***

Boy Scout camping trips provide a perfect setting for homosexuals to pursue their forbidden desires,

according to Reisman, who added that any organization that provides opportunities for homosexuals to spend time with young boys will become a magnet for homosexual child molesters.

In fact, Justice Ignazio Ruvolo of the First District Court of Appeals in San Francisco recently ruled that the Boy Scouts of America should be held responsible for a Southern California scout's sexual molestation at the hands of a pedophile scout leader. Why? In making his case that the Scouting organization - despite a comprehensive national program to prevent sexual abuse - should have done even more to protect kids from pedophiles, the judge said, "It should be reasonably foreseeable to the Scouts that a child participating in Scouting might fall prey to a sexual predator."

Attorney Charles A. Bonner, representing the victim who had been molested back in 1991 by his assistant scoutmaster, Jorge Paz, was even more direct. He said BSA national leaders know that "the organization attracts pedophiles like a magnet attracts metal."

Of all the various youth groups today, "the Boy Scouts provide the ideal situation" for men to find young boys to molest, according to Reisman.

The BSA does all it can to protect boys from child molesters, says Shields. Every "Boy Scout Manual" comes with an insert about child abuse placed in the front. Troops have a video to show to boys, entitled, "A Time to

Tell," which teaches boys to recognize attempts to sexually molest them, to resist the attempt and report the offender.

The BSA has strict rules designed to prevent child abuse of all kinds, said Shields. Rules include "Two Deep," which requires a minimum of two adults to be present with boys at all times. Another basic rule is that adults may not be in the same tent as boys (except their own children).

Shields told WorldNet that when the rules are followed, there are no problems.



Since the Supreme Court's June 28 decision in favor of the Boy Scouts, activist attacks on the 90-year-old organization have increased dramatically.

Homosexual political organizations have gone into overdrive, lobbying and threatening corporate sponsors to discontinue their support; President Clinton has been urged to step down as honorary president of BSA; a few members of Congress even tried - unsuccessfully - to revoke the organization's honorary charter. And Clinton even signed an executive order, which was followed in lockstep by a Justice Department memo designed to evict the Boy Scouts from federal lands and facilities - on the grounds that the organization illegally discriminates against homosexuals. All this, in spite of the Supreme Court's favorable decision three months earlier.

Although homosexual activists claim they are no more likely to sexually molest children than heterosexuals are, Reisman says research proves the opposite.

"They're claiming that homosexuals are not looking to have sex with boys, yet you have this massive number of boys out there prostituting themselves. And how do you have all these Internet sites if they're not looking for boys? This is not heterosexual. By definition, when you're having sex with someone of your own sex, that's homosexual," Reisman said.

Based on data from a study of non-incarcerated child sex offenders, Gene G. Abel, M.D., has found that homosexuals "sexually molest young boys with an incidence that is occurring five times greater than the molestation of girls."

A professor of psychiatry who has taught at several medical schools, including Columbia University College of Physicians and Surgeons, Abel is currently affiliated with Emory University School of Medicine and Morehouse School of Medicine. He has been a research scientist in the field of sexual violence for 25 years, and the National Institute of Mental Health has awarded him funding for six long-term studies to investigate sexual violence and to design new ways to stop it.

Specifically, Abel's report provides data to show that, on average, 150.2 boys are molested per homosexual pedophile offender, whereas only 19.8 girls are molested per pedophile heterosexual offender. Incredibly, homosexual offenders admitted between 23.4 and 281.7 acts of molesting boys.

Reisman's research in "Crafting 'Gay' Children" determined that the total population of homosexual men in America was no more than 2 million in 1991. During the same year, "U.S. Population, Statistical Abstracts" show that 6-8 million boys age 18 or under were sexually abused.

Meanwhile, the population of heterosexual men in the U.S. was approximately 86-88 million in 1991, and an estimated 8 million girls were sexually abused that year.

Based on the "Statistical Abstract of the United States, 1992, Data on Boys and Girls," published by the U.S. Commerce Department, Reisman cites the following:

Of 86 - 88 million heterosexual men, 9 percent of them victimized 8 million girls, age 18 or under, which constitutes 25 percent of all girls.

# RAPE OF A SACRED TRUST

## How pedophiles have targeted the Boy Scouts of America

Many homosexuals are attracted to young boys, they fantasize about young boys, they frequent websites about young boys, they cruise the streets for young boys, and they volunteer as Boy Scout leaders in an attempt to have sex with young boys, according to a world-renowned researcher and author.

Dr. Judith Reisman, formerly a research professor at American University, veteran pornography researcher and expert witness before the attorney general's commission on pornography, is the author of "Kinsey: Crimes and Consequences."

Having extensively researched the homosexual lifestyle, Reisman and other experts have reached some disturbing conclusions. Contrary to the popular view that there is little crossover between homosexuality and pedophilia, she says homosexuals are anxious to recruit young boys, a practice that is becoming easier thanks to sex education and "diversity programs" in schools that teach children to consider homosexuality as both acceptable and normal.

In one of the major cultural battlefronts of the year, the Boy Scouts of America has taken the legal challenges to it before the Supreme Court and won the right to deny avowed homosexuals entrance as adult leaders. Nevertheless, ever since the BSA's founding early last century, it has been plagued with a constant undercurrent of pedophile scout leaders preying on the vulnerable, trusting boys they "lead."

Greg Shields, Boy Scouts of America's national spokesman, says homosexuals cannot serve as exam-

ples to young boys because they do not live by the Scout Oath to be "morally straight." Although painfully aware of the problems BSA has had over the years of men preying on boys, Shields takes a somewhat corporate and elusive line in separating the organization's homosexual policy from its child sexual abuse policy.

"Unfortunately, child molestation can come from anyone. We are teaching boys character values. Everyone knows where we stand on this. We have never accepted homosexuals as leaders and we never will," said Shields.

Reisman says what 90 years of police blotter statistics prove - that young boys are in real danger of sexual molestation, and that the BSA has sound reasons to ban homosexuals.

Reisman conducted two recent scientific studies that challenge the popular mantra of homosexual activists who insist that: 1) they are "born that way," 2) homosexuals make up 10 percent of the population, and 3) youths should be able to have sex at an early age.

"Crafting 'Gay' Children: An Inquiry into the Abuse of Vulnerable Youth Via Establishment Media and the School Room" and "Partner Solicitation Language as a Reflection of Male Sexual Orientation," are continuations of the work Reisman began with her study, "Kinsey: Crimes & Consequences."

Regarding her book, Charles E. Rice, professor of law at Notre Dame Law School, notes, "Dr. Reisman's study supports the conclusion that Alfred Kinsey's research was contrived, ideologically driven and misleading. Any judge, legislator or other public official who gives credence to that research is guilty of malpractice and dereliction of duty."
