

**Remarks of Eunice V. W. Ray,
Co-Founder, *RSVP America* Campaign**

**U.S. Capitol
October 2, 1997
Press Conference**

It is a great privilege for me today to stand with Dr. Beverly LaHaye, and Carmen Pate leaders of the 500,000 member strong Concerned Women for America and Dr. Judith Reisman, the woman who told me, a mother from Kentucky, about Dr. Alfred Kinsey. She told me Kinsey prophesied and promised those who adopted his sexuality model would have better sexual health and instead he gave us the sexual revolution and evolutionary sex education. At the 50th anniversary of his seminal research, it is time to ask America, "Are you better off in 1998 than you were in 1948? The answer is a resounding no!

There is a reason. With inaccurate and criminally derived data you get very bad results. Sexual disease and dysfunction is at toxic levels. Our families and our nation are sick because of fraud in science. Those of us born after WWII who came of age in the 1960s have learned that "free love" is not free to the tax payers in the 1990s.

Dr. Reisman's discovery in 1981 and her call to the scientific community to investigate the crimes against children at the heart of Kinsey's report and findings is an even more egregious example of scientific deception than the syphilis experiments at Tuskegee, Alabama. "Trained observers" with stop watches molesting children and calling it research may be defended here in Washington, but where most Americans live it is totally unacceptable and indefensible.

Upon reading Reisman's work, Walter W. Stewart, world renowned research scientist, who's expertise is in uncovering scientific fraud at the National Institute of Health said unequivocally, that Dr. Reisman had, raised

"serious and disturbing questions about the accuracy, reliability and, perhaps, truthfulness of the figures given in Kinsey's 1948 book and the methods by which these data were obtained. Because of the obvious importance of Kinsey's work these questions need to be thoroughly and openly debated by the scientific community,"

In 1991, the eminent British journal the Lancet echoed the importance of her earth shattering discovery and the necessity of her call for a long overdue public investigation into Kinsey's flawed research. The Lancet said;

"In Kinsey, Sex, and Fraud Dr. Reisman and her colleagues demolish the foundations of the two reports . . . (including) stimulation to orgasm in young children . . . Kinsey . . . has left his former co-workers some explaining to do." 1

We were here in December 1995 when forty one Congressman co-sponsored the Child Protection in Ethics and Education Act which sought to investigate the criminal and fraudulent basis of Dr. Alfred Kinsey" publicly funded sex research.

Congressional leaders and staff members and key committee chairman told me and others that the billion dollar sex industry has many quiet friends and supporters on Capitol Hill and is well-entrenched. The timid and faint of heart told me, a little mother from Kentucky, that hearings won't be held or an investigation successful unless you come back here reinforced with an army of mothers, demanding the public investigation, only then this legislation will move.

That Congressman was right and that's why were' here today with Dr. Beverly LaHaye and her army of more than 500,000 mothers. They represent political clout and that is Congressional currency. CWA will provide our nation with the source of the problem and a solution. Because Americans are all are concerned about the demoralization of America, the loss of Virtue throughout our society, especially among our leaders and the increasing threat to our children

CWA will lead hundreds of thousands of mothers, grandmothers, and many other American women who will be proud to join with us and stand with Beverly LaHaye to expose Alfred Kinsey and his publicly funded research. Fifty years is enough. It is time to stop the lies and the terrible consequences.

Thank you Dr. LaHaye for inviting me here today.

Science turns the wheels of law and public policy. Americans create and eliminate laws and invest trillions of tax dollars on those public policies which have been sanctioned by science. In 1948, Dr. Alfred Kinsey published a report on human sexuality which was believed throughout most of the western world. Thirty-three years later I discovered that the Kinsey Reports were based on fraud, and in fact, on child sexual abuse *as a scientific research protocol.*

On March 2, 1991, *The Lancet*, the British medical journal reported, "**Dr. Judith A. Reisman and her colleagues demolish the foundations of the two [Kinsey] reports.**" The two key *scientific* issues are the deviant male sample and the child sexual abuse conducted by "pedophiles--*or so it must be hoped.*"¹

This was ten years after my 1981 expose of Kinsey's crimes at the 5th World Congress of Sexology. For, the Kinsey Institute secretly had lobbied the media, universities and the Legislature, *as they are surely doing today*, defending Kinsey and attacking my credentials with phone calls, faxes, letters and 87 pages of disinformation.

As covert documents, these 87 pages were sealed by a Kinsey Institute "Confidential" disclaimer telling recipients to use the Kinsey materials but, to deny anything came from the Kinsey Institute! These slanders triggered my lawsuit against the Kinsey Institute, yielding massive evidence of on-going, premeditated fraud, beginning with Kinsey and percolating down through all of his subsequent Directors.

For example, on December 6, 1990, Paul Gebhard, former Kinsey co-author and Institute Director wrote privately to June Reinisch, then Kinsey Institute Director, that while I was right about Kinsey's fraudulent data and she was wrong, they must hide the truth:

In your recent letter of December 3, *which I gather was sent to a number of individuals as well as to me*, you refuted Judith Reisman's allegations about Kinsey and the Institute. *However I fear that your final paragraph....may embarrass you and the university if it comes to Reisman's attention. Hence I want to warn you and relevant university officials so that some damage control might be devised.* (emphasis added). [For your] statement is incorrect. Kinsey did mix male prison inmates in with his [Male] sample[and] Kinsey did generalize to the entire U.S. [Male] population. **** I am distressed that neither you nor your staff seem to be familiar with Kinsey's first book nor with The Kinsey Data and consequently produced the erroneous statement in your letter.

My friends, a recurrent Kinsey Institute “damage control” technique has been to infer that because I abandoned my lawsuit due to my lack of funds, Kinsey was innocent. But the Kinsey Institute smear campaign proves it does not seek truth but more fraud to cover-up its history of crimes against children, women, and humanity. If not culpable, the Kinsey Institute would welcome a Congressional inquiry.

Since *The New Yorker* already revealed September 1, that Kinsey’s sordid sexual preferences--somasochism, homosexual exhibitionism, prostitution of his wife, staff members and so on--fits a sexual psychopath profile. What *more* can the Kinsey Institute be hiding?

As noted, Kinsey’s two primary crimes which have had, and continue to have, a devastating impact on American life are (1) his statistical data are fraudulent; (2) his child sexuality data were collected by pedophiles using chiefly “manual and oral” techniques on 317 plus infants as young as 2-months-old. Dr. Gebhard is on record confirming these as crimes.

I will deal with the statistical problems first: In the late 1970s, a colleague, knowing of my concern about the escalating rates of child sexual abuse, suggested I study the famous Kinsey Reports. As I read *Sexual Behavior in the Human Male*, I saw that Kinsey’s data included prisoners, sex offenders, homosexuals, pimps, male prostitutes, etc., as average American Males

Since few American males in Kinsey’s era had the sexual habits of such men, Kinsey’s book would more accurately have been entitled, *Sexual Behavior in the Deviant Male*, thereby allowing the nation to enact measures to avoid the sexual conduct Kinsey described as this male norm, lest we program, as obviously we did, an epidemic of male psychosexual pathology.

Most recently, Allen Wallis,² past president of the American Statistical Association wrote “Your forthcoming book on the Kinsey research does an impressive and important job of exposing how heavily Kinsey's data relate to criminals and sex-deviates....your figure of "roughly 86 percent" of Kinsey's sample having been male deviants appears to be in the right ball park.” Wallis added that 25% would be devastating.³

However, more unsettling than his science fraud was Kinsey's child “orgasm” data, notable in Chapter 5, confessions of criminal wrongdoing against at least 317 infants and boys. Under scientific cover Kinsey authorized and reported sexual “orgasms” on these small “subjects.”

How did Kinsey know infants who could not talk had experienced an “orgasm?” He described the “orgasmic” behavior of these babies in his book as follows:

violent convulsions.... spasmodically twitching... groaning...sobbing...violent cries (an abundance of tears especially among younger children)... trembling, collapse...faintingstriking the partner to get away....although [Kinsey concluded] they derive definite pleasure from the situation.⁴

No one has the right to molest children for his “scientific” data. Being a member of the field of science is one of privilege and trust, investing one with a mantle of objectivity and authority. Therefore, scientists are held to a higher standard of trust than others, especially today, when science, that is scientists, turn the wheels of law and public policy.

Today, I am proud to stand with Dr. Beverly LaHaye and the 500,000 Concerned Women of America who are calling for a federal investigation into Kinsey's data for “any fraud or criminal wrongdoing.” I am saddened and embarrassed that the scientific establishment itself will not investigate these reports.

But as women concerned about children and America, we will stand for those little ones who had no one to protect them against powerful and brutal forces. Congressmen, do not be intimidated by the censure you will receive from large and corrupt special interests who react cruelly to any light being shone onto Kinsey's research. This is the third call for Congress to investigate Kinsey: **1954 WAS THE FIRST TRY, 1995 WAS THE SECOND. BUT IN 1997 WE BEGIN WITH 500,000 WOMEN DEMANDING JUSTICE**, demanding a congressional investigation of Dr. Kinsey.⁵ Yes, the time is our time and our time is right.

I will make this prediction as I have before. If Congress is satisfied that there is crime and fraud in the Kinsey Reports, whole shelves of books will have to be rewritten. Both public and religious schools will have to discard their AIDS prevention and sex and family-life education

courses. Lucrative public grants will dry up. Current sex authorities will be seen as con artists, fools or criminals. Not since Tuskegee will so much shame be written on so many scientific faces.

Come forward as our representatives. Fulfill your responsibilities, your mandate from the people you serve. Expose the truth whatever it is. The concerned women of America everywhere and our children deserve no less. Thank you.

Restoring America's Social Virtue and Purity makes economic sense. Billions of tax dollars are spent every year to support programs and policies which purvey the fraudulent Kinseyan view of sexuality. Dr. LaHaye has declared, "CWA will Unmask Kinsey and stop Kinseyan programs from reaching children with information that is neither accurate or health or age appropriate. Kinsey robbed America of her virtue. Is it any wonder we are experiencing a crisis of vice?"

Eunice Ray, co-founder of *RSVP America*, will join with Dr. Beverly LaHaye on the Capitol steps on October 2, 1997, 10:00 a.m., and together they will call for the restoration of social virtue and purity to America. Dr. LaHaye will call for a Congressional investigation into the Kinsey Report's fraud, "skewed" research and inaccurate fraudulent data which has been influential in changing laws and public policy. A primary reason for the call for an investigation is the sexual abuse of infants and young boys detailed in Table 34 of Kinsey's own book *Sexual Behavior in the Human Male*. Mrs. Ray said that, "Human sex experimentation on children violate all standards of human decency and use of any data obtained without informed consent should be prohibited."

The *RSVP America* campaign is being promoted by Concerned Women for America (CWA), the largest women's organization in America, to its half million activist members across the land. The *RSVP America* campaign is a grass roots campaign designed to answer the question of how America has gone from "Chastity to Condoms" - in the baby-boom generation. The campaign will expose to parents the destructive influence of Alfred C. Kinsey's criminally derived view of human sexuality, particularly in the education of their children. According to Ms. Ray, "The adoption of the Kinseyan model of "anything goes" sexuality, documented by fraudulent research and data, has been harmful, unhealthy and demoralizing to the nation and costly for the tax payer."

Dr. Beverly LaHaye, CWA Chairman and Founder, will call for the unmasking of Kinsey and a stop to public funding of Kinseyan-based programs which provide "skewed" sexuality

information that is “neither accurate or age and health appropriate.” Dr. Judith Reisman, author of an upcoming book on Alfred Kinsey, which totally debunks Kinsey’s human sexuality myths, will also speak on the current Kinsey Institute efforts to whitewash Kinsey’s methods and cover up criminal acts committed in the name of research and science.

Ms. Ray, a mother of four, was alerted to the trouble with Kinsey’s research when she learned of the children of “Table 34,” sex research conducted by pedophiles who violated children, including infants, for whom no one could give consent for their sexual violation for any reason. The pervasive use of Kinsey’s data in America’s schools led Ray to co-found the *RSVP America* campaign to alert parents at the grass roots to the dangers associated with Kinsey’s “free love” sexuality model. Ray is campaigning for women across America to know that sex education in America is based on the sex research conducted by a sado-masochist whose Report reflects at least 44 crimes and the sadistic prostitution of his wife for “science.” That can’t be any better for children today than it was for the children of Table 34.

RSVP America is offering educational materials at the grass roots: a training manual designed to fully familiarize parents with the Kinseyan view of human sexuality and what it means to them and their children; a sex ed curriculum analysis document that assists parents in verifying the bias toward the “skewed” Kinseyan model in textbooks and other documents; and *The Children of Table 34* video produced by the Family Research Council.

“The *RSVP America* campaign exposes Kinsey’s greatest flaw and vulnerability,” states Ms. Ray, referring to Dr. Reisman’s discovery of Kinsey’s “trained observer” pedophiles who “timed” their abuse of 317 infants and young boys with stop watches which are recorded in Kinsey’s first report 50 years ago. Ray says, “America is not ready to give up her young sons and daughters to sexual abuse by adults for any reason, in 1948 or in 1998.”

RSVP America is proud to join its information campaign with the organizational strength of Concerned Women for America, as together they supply America’s mothers and fathers with the crucial information and tools to analyze and remove the extremely destructive Kinseyan Model from the lives of their own children.
