TAX EXEMPT FOUNDATIONS FINANCE SUBVERSION*

By Norman Dodd, Director of Research, Special Committee, U.S. House of Representatives to Investigate Tax-Exempt Foundations, 1954. From an address given in Washington, D.C., 15 October, 1976.

This is not going to be a speech. This is a sharing of ideas born of experience and I would like to begin by qualifying myself in your minds. I am a product of a strange type of education and schooling. The education of which I am a product featured the importance of the question "Why?." And then went on to try to instill in us the importance of the question, plus our responsibility as individuals to find the answers. I happen to have taken this education and schooling seriously and I have lived accordingly.

In this schooling to which I was subjected, great stress was laid upon the history of this country — to illustrate the feature I have just mentioned. As a result, I participated in and was witness to something in the nature of a discovery, which was that in the 200 years of our history many more truths made themselves self-evident than motivated our Founding Fathers. One of these truths bears heavily upon the experiences that I shall recite to you.

GOVERNMENT & MONETARY POWER

This truth, were it to be put in words, would read something like this: (I will repeat it slowly because it is quite significant and deserving of considerable thought.) This truth reads as follows: The condition or state of the members of any nation at any given time reflects the use to which the wealth they have produced is

being put by others than the ones who played a part in its production.

That brings me to two experiences which I will describe to you. The first was my response to an invitation during November, 1953, from President Roman Gaither of the Ford Foundation, to meet in his office in New York. Upon arriving there, I was greeted with the following:

"Mr. Dodd, we invited you to come because we thought that perhaps, off the record, you would be kind enough to tell us why the Congress is interested in the operations of foundations such as ourselves." Before I could think of how best to reply, he volunteered this: "Mr. Dodd, we operate here under directives which emanate from the White House. Would you like to know what the substance of these directives is?"

My answer was, "Yes, Mr. Gaither, I would like very much to know."

FORD FOUNDATION: MERGE U.S. & RUSSIA

Whereupon he said: "The substance of the directives under which we operate is that we shall use our grant-making power so to alter life in the United States that we can be comfortably merged with the Soviet Union." Needless to say, I nearly fell off the chair. Before I could recover myself and reply, I said, "Mr. Gaither, legally you are entitled to use your grant-making power for this purpose but I do not think you are entitled to withhold this information from the American people to whom you are beholden for your tax exemption. So why do you not tell the American people what you have just told me?"

His answer was: "Mr. Dodd, we would

not think of doing that."

That was one experience that was very informative. It was incredible. Nevertheless it is the truth.

CARNEGIE ENDOWMENT FOR INTERNATIONAL PEACE

The next experience involved the acceptance of an invitation from the Carnegie Endowment for International Peace. This invitation came in response to a letter which I had written the Endowment asking a few pertinent questions. By pertinent I mean that they related to the effort of the Congress to determine if foundations were engaged in what the Congress said could be un-American activities without defining un-American. I arrived at the office of Dr. Joseph Johnson, who was then President of the Endowment. He was the successor to Alger Hiss. Present were two Vice-Presidents, relatively new men, and Counsel, a partner in the law firm of Sullivan and Cromwell. After amenities, Dr. Johnson opened the conversation this way: "Mr. Dodd, we have received your letter. We can answer the question but it will be a great deal of trouble. The reason for its being a great deal of trouble is that with the ratification by the Senate of the United Nations treaty, our task was done. And so we bundled up everything in the way of record and sent them to the warehouse and adopted a policy of constructing a building across the street from the United Nations which served as a facility for the benefit of those many organizations which, from this point on, would be bound to follow the activities of the United Nations. So we have a counter suggestion which is as follows: If you can spare a member of your Staff and send him to New York for two weeks, we'll provide a room in our library and also make available to him the minute books of the corporation from its inception."

My first reaction was that he had lost his mind. I had some suspicion what these

minute books might well contain. But here was Counsel and there seemed to be no disagreement on the part of the Vice-Presidents and all of them were relatively young. So my guess was that none of them had ever read the minutes themselves. As a result I accepted the invitation and did send a member of my Staff to New York. That member brought back to me on Dictaphone belts the following:

WAR, INSTRUMENT OF CHANGE

We are now back to roughly 1908 when the trustees raised a question, asking themselves: "Is there any way known to man more effective than war, assuming they wish to alter the life of an entire people?" They discussed this question academically and in a scholarly fashion for almost a year and came up with the conclusion that war is the most effective means known to man, assuming that objective.

They then raised Question No. 2: "How do we involve the United States in the war?" This was in 1909. I doubt if there was any subject more removed from the minds of people in this country at that time than the possibility of involvement in war. There were intermittent shows, you will remember, in the Balkans and my guess is that not many people in the country knew where the Balkans were. They answered the question this way: "We must control the diplomatic machinery of the United States."

That brings up Question No. 3 which is: "How do we secure control of the diplomatic machinery of the United States?" And the answer comes up, "We must control the State Department."

That fits in with prior findings which we had uncovered, namely that the hand of the Carnegie Endowment for International Peace inside the State Department was a fact.

Finally, we are in a war. These Trustees have the brashness to congratulate themselves on the wisdom and validity of their original decision. Because already the impact of our participation in World War I has indicated its capacity to alter our national life. They even go so far as to word and dispatch a telegram to President Wilson, pressuring him to see to it that the war does not end too quickly.

ROCKEFELLER FOUNDATION & REVISIONIST HISTORY

Finally the war is over. The Trustees then take up the problem which they face, namely of preventing – as they put it – a reversion of life in the United States to

what it was prior to 1914. They come up with the conclusion that to gain that end we must control education in the United States. They realize this is a prodigious piece of work, so they seek and obtain the assistance of the Rockefeller Foundation. They then divide the task in parts, giving to the Rockefeller Foundation the responsibility of altering education as it pertains to domestic subjects. They retain for themselves the task of altering our education as it pertains to subjects bearing on our international relationships. They then decide together that the key this is an alteration in the teaching of American History. So they approach three of the then existing prominent historians with the proposition that they alter the manner in which up to then they had presented the subject. They were turned down flatly. They then decide that it is necessary for them to build their own stable of historians. Then they approach the Guggenheim Foundation which specializes in the awarding of fellowships and suggest: When we discover a likely young person who is studying and looking forward to becoming a teacher of History, we will take him to London to pursue his studies. So they take 20 to London and there these 20 are briefed in what is expected of them. These 20 return and eventually become the most active influence in the American Historical Society.

This coincides with the appearance (which perhaps you will remember) of book after book, the contents of which cast aspersion on the founders of this country, cast aspersion on the ideas which prompted the founding of this country and relegates them to the realm of myth.

THE AMERICAN HISTORICAL SOCIETY

Finally, toward the end of the 1920's the Endowment grants the American Historical Society \$400,000 for the sole purpose of rendering a report as to what the future of this country promises to be and should be. This appears in seven volumes. The seventh volume, of course, summarizes the contents of the other six and ends on this note: The future belongs to collectivism, administered with characteristic American humanitarianism and efficiency.

Well, in a sense this was the whole story written down and Mr. Reece who was Chairman of the investigation, the last investigation of foundations, hoped to be able to accomplish this. He was not able to do this owing to the disinterest on the part of the Committee's Counsel and the violent activities of one of its members. I might mention that that member whose activities barred the way, was none other Wayne

Hayes who has come to the end of his career, although this marked the start of it.

What this leads to is the possibility of ascribing that which is happening in our country to the failure of our scholars to extract from experience those truths which make themselves self-evident. Had our Founding Fathers lived today, I'm sure they would have added to the few they cited to justify their Declaration of Independence. But in the meantime certain practices made it possible for those whom I mentioned, who had command of wealth, to accomplish their goals and bring these conditions about. These practices total seven and they must be brought to an end.

THE SEVEN DEADLY AGENCIES OF SUBVERSION

The first of these practices is **collective bargaining**.

The second is **compulsory education**.

The third is **monetizing of debt**.

The fourth is what is referred to as **fractional reserve central banking**.

The fifth is **government by administrative agency**.

The sixth is **administrative law**.

The seventh is **incentive taxation**.

The practices have contributed to placing us in a trap and they form the elements of the trap which has been placed before us. They must go. But they cannot go until the function of which these practices were supposed to perform become assigned to some other private agency rather than a political one.

These new institutions and transfer of practices toward given goals have not been thought through. Those who have benefited from these practices fear, as we fear a plague, that somewhere, somehow, somebody is going to become very curious and think through, while announcing to the American public, that the contribution of these practices to the conditions of the present day have enabled wealth to be used to bring about the predicament that we are now in. All the information that is needed to justify such an announcement exists. It has, however, never been assembled for that purpose. It exists there. Those who have produced it have mistaken their part for the whole and have drawn erroneous conclusions from it, the gist of which is that we can be protected from this trap entirely through the political world. There it is impossible. It must be done in combination by the power of American Industry demanding changes in the world of education. I hope that you will give this some thought and realize that for the first time in human history this cycle of a rise in a civilization and a fall can now be broken.

COVERT CONTROL* OF THE NATION'S MONEY

As in the days of the Jacobin Society, control of government for subversive purposes is achieved by securing covert control of the nation's money. The power of the purse was transferred from the Congress to the hands of internationalists by passage of the Federal Reserve Act of December 23, 1913. Since that date, the members of the Council on Foreign Relations whose Regents are holders of the Class "A" stock of the Federal Reserve System, have dictated the course of the American destiny and the future of her people.

FEDERAL RESERVE SYSTEM

"... We have in this country one of the most corrupt institutions the world has ever known," said Congressman Louis T. McFadden. "I refer to the Federal Reserve Board and the Federal Reserve Banks."

"... When the Fed (Federal Reserve Act) was passed," said Congressman McFadden, "the people of these United States did not perceive that a world system was being set up...A super-state controlled by international bankers, and international industrialists acting together to enslave the world for their own pleasure!"

"Every effort has been made by the Fed to conceal its powers," he continued, "but the truth is - the Fed has usurped the Government. It controls everything here and it controls all our foreign relations. It makes and breaks governments at will."

"... I charge them," Mr. McFadden declared in his bill directing investigation of the Federal Reserve, "... with the crime of having treasonably conspired and acted against the peace and security of the U.S. and with having treasonably conspired to destroy constitutional Government in the U.S."

The names of the chief conspirators, who pose as the protectors and benefactors of mankind while secretly furthering nihilistic objectives, adorn the rosters of honorladen organizations and societies in America and in Europe. They don the protective cloak of respectability in observance of the rules of conduct

established by their dark leader, Adam Weishaupt, who ordered:

ILLUMINATED REGENT

"The Illuminated Regent shall be one of the most perfect of men. He shall be prudent, foreseeing, astute, irrefragable (Instruction B, for the grade of Regent)."

He shall also be, as has been illustrated in this study, a maitoid - a man of unbalanced and dangerous brilliance.

Many Americans are convinced that these political madmen must be isolated and neutralized if the American social structure is to escape extinction, and if our children are to survive and serve as the living foundations of a free civilization.

This brief and necessarily incomplete study - its thesis supported by authoritative documentation available to any researcher - should bring the reader to three obvious conclusions, ball game, football game or by any number of other diversions that are continually waved before us.

If we want bread and circuses, then what we're going to get is Socialism. If we want to make our principal pass time, our principal activity, the running of our own affairs and the reinstallation of Constitutional control over our currency, then we will find that the support of such organizations as the Oregon Legislative and Research Committee will reward our individual efforts, which will be responsive to a real national and local need.

Therefore, those who have elected to forego the entertainments of the hour to come here to study the question of what to do about our money system are to be commended. It is the people right here in this Auditorium upon whom the well being of our Republic rests.

Those of us who have studied the American Revolution realize that it took a very small percentage of the American people to accomplish that feat. The burden rested upon relatively a few shoulders. The fact that we can see about us others who appear to be more interested in other things should not dissuade us. We should be prepared to give of our substance and our time to such organizations as this, that have a positive remedy that is something other than a Socialist remedy: A remedy that has been proven, a remedy that will work; and a remedy for which our posterity will thank us, if we are able to accomplish it.

SOLUTION

To 'Boom' & Bust' Economy

On 23 December 1913 the Congress of the United States adopted the Federal Reserve Act (HR 7837) in violation of Article 1, section 8, Constitution of the United States.

By this illegal act the Congress transferred the power to borrow money on the credit of the United States, and the power to coin money and regulate the value thereof, from the Congress to a cartel of international bankers.

Mission of informed citizens is motivation of County officials (the County is the building block of the American political structure) to direct their State lawmakers to neutralize the international banking cartel and restore control of government to the people. Citizens, source of all political power, are responsible for instructing County and State elected officials to direct 'their' agents in Washington to confine the functions of government to limitations defined in the Constitution of the United States.

The law involved is the fundamental law of 'Principal'. Actions by an Agent are not binding on the Principal if those acts are not authorized by the Principal. Constitutionally, departments of the Federal Government are Agents of the States which created them. Executive, Legislative and Judicial departments of the Federal Government were founded by the original thirteen Nation States by the first three Articles of the Constitution. Violations of the Constitution by Federal Agents are therefore subject to correction by the State.
