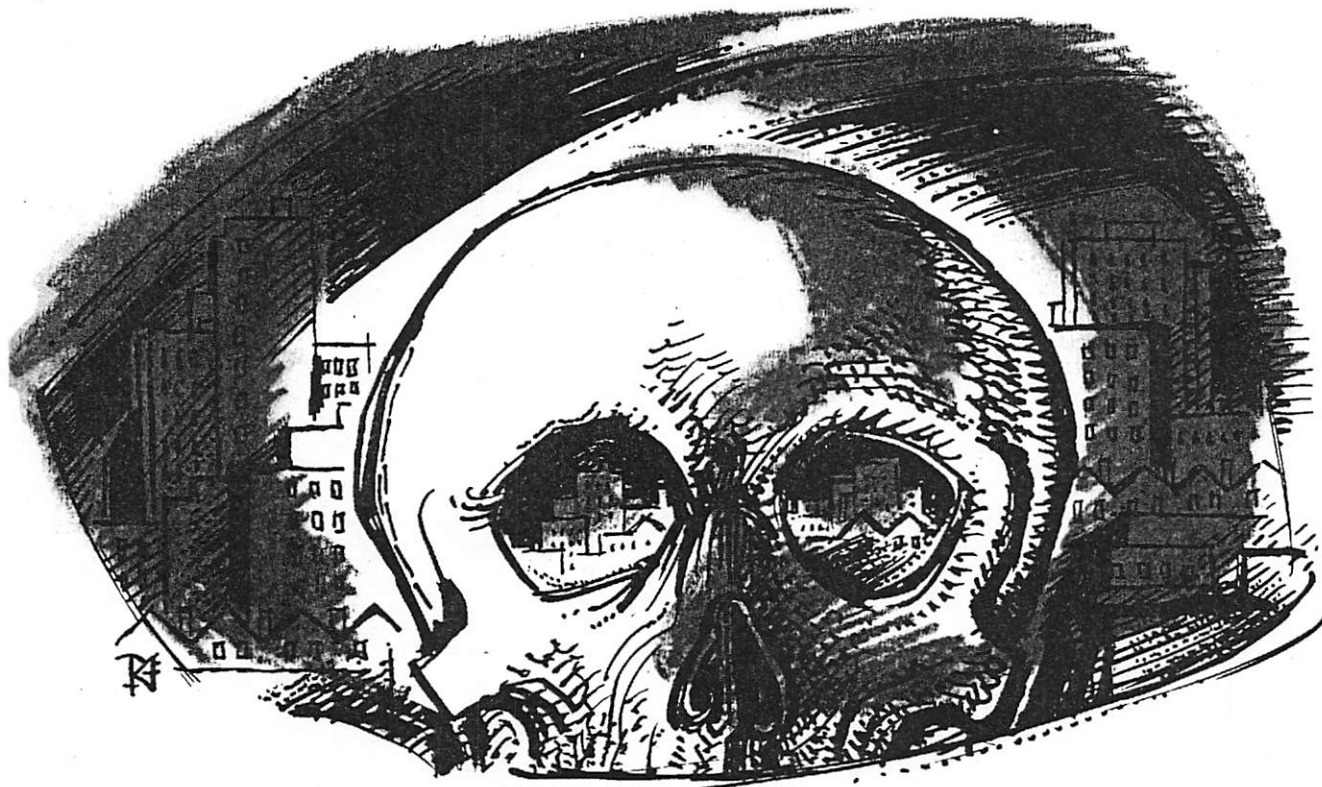


Culture of Death Watch



The Fisting of America

Planned Parenthood distributed kits for fisting and oral sex. They contained a single plastic glove, a package of KY lubricant and instructions on how to make a 'dental dam' from the material. (03-26-01)

Within a month of the October night in 1998 that 19-year old Matthew Shepard was beaten and left to die, 3077 stories appeared in the media about the crime. Eleven months later, 13-year old Jesse Dirkhising was tied up by two grown men who sealed his mouth with duct tape and gave him an amitriptyline enema. One of them, Joshua Brown then raped him until he suffocated to death. They didn't beat him and leave him to die; they tortured him and sexually abused him in the most unnatural fashion, and murdered him in the act. Yet, as journalist Andrew Sullivan wrote, in the month after the horrific sexual murder of Jesse Dirkhising, the media coughed up only 46 stories

(Robert McCain, *Washington Times*, 03-23-01). That ratio tells the truth about the priorities and secrets of those interests and individuals that now dominate American media.

The professors of sensitivity and progressive causes used to discern imbalance everywhere, in advertising, entertainment and school curriculum. Often enough, such emphases only reflected millennia-old standards of normalcy and decency. Sometimes they reflected the gap between faked "research" and its statistical claims (the 10 percent gay myth, the bisexuality as the norm myth) and demonstrable truth. But they don't talk as much about imbalance anymore now that they have mandated or established,

through their own hegemony, their own rather skewed notion of the abnormal as normal.

When the guilty verdict came in for Joshua Brown, Reporter McCain called the networks to ask if the disparity in covering the two cases might have reflected political preferences rather than a simple desire to get and transmit the facts. "Absolutely not," said a CBS spokeswoman, as emphatic as she was incredible, as credible as CBS generally. "We only have twenty-two minutes on CBS Evening News," she added. "We can't cover every story that happens in the country every day." True, certainly true, but there are some stories that are rather enormous in their type and implications, particularly in their relevance to certain agendas that the networks promote assiduously. "But the overall editorial

judgment was that it [the jury deliberations and verdict of guilty] wouldn't fit into the broadcast that day." The homosexual rape and murder of Jesse Dirkhising clearly didn't rate the 100 stories/day blitz of the Mathew Shepard case, not at CBS.

Not anywhere else, either, certainly not at ABC. "It appears to be a local crime story that does not raise the kind of issues that would warrant our coverage," sniffed Todd Polkes, who just might practice homosexual activities himself, if the figures cited by *New York Times* political correspondent Richard Berke are correct. "Literally three-quarters of the people deciding what's on the front page [at *the Times*, America's "paper of record"] are not-so-closeted homosexuals" he stated to a conference of the National Gay & Lesbian Journalists a year ago.

In October and November 1998, politicians and Hollywood celebrities swarmed all over the Shepard case, despite pleas from the youth's mother not to politicize his death. Richard Gephardt, Teddy Kennedy and Ellen DiGeneres, supported by Mr. & Mrs. Clinton demanded new hate crime laws, and used the occasion to create the 'fact' of a wave of "anti-gay" violence. The Gay & Lesbian Alliance Against Defamation (GLAAD) arrived in Wyoming and explained the "truth" of the crime to the media. There was a "climate of hate" created by conservatives, the same ones who supposedly shot Dr. Barnet Slepian and were responsible for the bombing of the Murrah Building and the Japanese attack on Pearl Harbor, and... There was an election on then, and it was very important for Democrats and their allies to get the correct message out about indirect Republican complicity for the "climate" that supposedly

suggests that it is not the victims whom she now strains to protect. "It's the facts of this case, the brutal details of this are what is on trial," she claimed (McCain, *ibid.*). Firstly, there is no evidence, as opposed to assertions, that "hate crimes" are "directed against an entire group of people." In terms of aggravated assault with sexual violence, and the age of the victim, the murder of Dirkhising was worse, its aggravated aspects amply covered by law. Moreover, his murder was, at least by the standards of "hate crimes," potentially directed against an entire class of people, boys without strong families or with inadequate self-defenses, that are the prey of homosexual men. And it turns out, of certain kinds of middle-aged women.

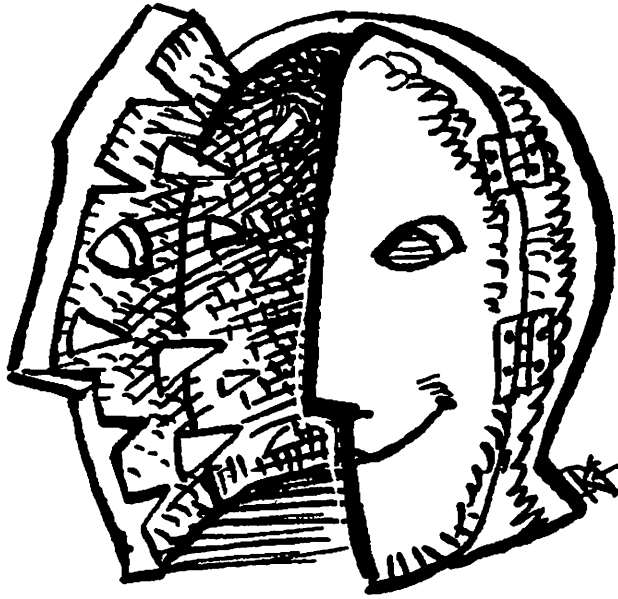
Not only was the Dirkhising case all but buried by the media, several of its aspects were glossed over even by those few that did cover it. Jesse was raised mainly by his grandmother, who thought it appropriate for a boy without a father in his life to work in a beauty salon owned by two flagrant homosexuals. Perhaps she thought it was quaint. Maybe she thought, as it states on those "sensitivity" quizzes in Massachusetts' schools, that he "just needed a good gay relationship." Mom was too busy pursuing her life with stepfather to raise, educate, and protect her son. The stepfather may have been a friend of the homosexuals. It was alleged that he sold them drugs, though that hardly gave them a license to rape or kill. In any case, grandma sent Jesse into harm's way. None of these adults were involved

led to the death of Shepard. After all, DNC ads claimed that the GOP was responsible for setting fires in black churches. It all follows from claims such as that one.

GLAAD's spokeswoman, Cathy Renna, says the Shepard and Dirkhising cases are very different, and that "comparing them does an injustice to both victims" although her explanation for why this is so



enough to prevent or stop Jesse's drug use. Or his spending time, on breaks from the hair salon where his eventual murderers worked, with a 43-year old woman who found it stimulating to shoot him up with amphetamines (*Arkansas Democrat-Gazette* 03-21-01). She too must have been amused or aroused at the sight of a 13-year old boy becoming effeminate and entranced by drugs, a victim male ready to be sacrificed on the altar of the homosexual cult, with its own unique incense of media apologetics and material ingredients. The apartment of the murderers reeked of excrement and was littered with drug paraphernalia and residue. No, traditional families are not like these new kinds of "homosexual unions" or domestic partnerships that tend to accrue different kinds of interest.

But it's "just a local crime story that does not raise the kinds of issues that would warrant coverage" from ABC. These kinds of issues are meant to remain deep in the closet, out of sight and out of mind, and they probably will until they are epidemic, and maybe even then people will be helped or warned to look away.

JUST A LOCAL EDUCATION STORY

The lessons of the kinds of murders, and media selectivity described above, are being learned and applied in ways disturbing to most of the few people aware of what's occurring. Late in March 2000, in partnership with the Gay, Lesbian & Straight Educators Network (GLSEN), Tufts University hosted a "safe schools" conference. This was also a State-sponsored event because GLSN gets funds from the citizens of Massachusetts through their taxes, as apportioned by the essentially one-party State Legislature. That first conference featured homosexual and lesbian employees of the State Department of Education coaxing some of the high school students to discussions of clitoris size (a big one means you're "very gifted"), masturbation and oral sex techniques, and the use of evocative slang terms like "carpet-munching" and fisting. The lesbian defended the latter practice as "a way to get very close to your partner. It's not about pain," she claimed, probably without having been on the receiv-

ing end of the homosexual version of this act.

Two Massachusetts parents taped the proceedings and a transcript and subsequent descriptions and comments were published in the *Massachusetts News*, a monthly publication that has continued to cover the sexual revolution that is established in Massachusetts government and State institutions (Massnews.com for archive). Those parents are being sued by GLSEN, and if the grounds are unclear, the threat of financial ruin carries an unmistakable message. The Massachusetts Department of Education sought to defuse the matter by firing two of the low-level bureaucrats whose language had been particularly salty at the Conference. They were indignant, claiming, plausibly, that they were simply doing their jobs and carrying out Department and State policy. The *Boston Globe* owned by the *New York Times* has ignored mentioning much less trying to rebut the information published in the monthly *News*. Rather, it predictably reduced the entire matter to an outbreak of homophobia which continuing conferences must overcome.

Yes, the Conferences are continuing. Indeed, Ed Oliver reported that this year's follow up was much larger than the first "Fistgate" indoctrinate-the-young session, with about 400 of the 650 attendees being students. Public schools buses from at least two Massachusetts school districts had brought students from school for what the *Globe* termed an "Alert against threats to gay teens" (headline, inner section, 03-25-01). The day-long conference was an attempt, said the *Globe* (whose slant determines New England's official truth), to respond to an ostensible epi-

demic of suicide among gay youth and to "combat homophobia." Oliver reported that Tufts University provided massive security presence, so that it could not claim, as it had in 2000, that it did not know about the nature of the event. Commissioner Driscoll kept an official distance, this second time round, declining to send official, written greetings. Those were provided by Congressman Barney Frank, who practices homosexuality, and by State Senator Cheryl Jaques, who practices lesbian activities, perhaps including carpet munching, etc, and whose animus against fathers and families in the Legislature might be characterized as "fisting."

Oliver reported (*Massachusetts News* 03-26-01) that the Conference was aware that parents were trying to oversee events, and was not pleased. The press also was barred from most workshops, being confined to display tables in the hallways, lunch, and the awards ceremony. Even though he received a press kit, Oliver was put out of the workshop he briefly attended. One of them was titled, "Last Year's Setback" which detailed how GLSEN and the "gay" youth it seeks to nurture, recruit, and otherwise create and exploit with its leading messages have been "beset by attacks from reactionary forces." Some of these even came from "within the public education bureaucracy," a refreshing piece of news that may, however, refer to no more than Driscoll's sacrifice of the two cadres that had run the livelier 2000 sessions. The Conference warned that, as a result, there now "was backsliding in such areas as parental notification, teacher certification standards" [perhaps fisting isn't sufficient anymore to get a job, raises and promotions], student rights

regulations [fisting permitted in certain sections of every bathroom?] and HIV/AIDS parameters." This last area must refer to various kinds of instruction, materials provided, in "safe sex." It is difficult to see why GLSEN in Massachusetts would complain since a lesbian State Judge has upheld the right of a 13-year-old boy to attend school dressed and made-up as a woman and to be called by a woman's name. But then, the whole point is that they will complain regardless, because that is the first wedge of the judicial-legislative process. It is all part of the ongoing revolution against "reactionary forces." The workshop about the backlash from "reactionary forces" offered "strategic responses to such challenges." Reportedly, the series of articles in *The Massachusetts News* was to be addressed, but reporters were banned from the meeting.

state-employed workers that will go home and, mostly, forget all about it, and react angrily if anyone presents information that might awaken their guilt.

FIST-GATE II

A special guest speaker at Fist-Gate II was Hollywood producer and writer, Greg Berlanti (*Dawson's Creek*) who showed film clips of male baseball players "flirting on the field and exchanging a passionate kiss. 'You're so fun, so out,'" one exclaims before they head off, not into the sunset, perhaps, but toward a dark, excrement-befouled room like that where Jesse Dirkhising breathed his last.

"Most people have some attraction to the same sex during their lives," claimed a pamphlet titled, "Be Yourself," distributed by

The concern about certification and promotions for participating in these types of Educational and Health activities were addressed by GLSEN issuing "certificates of completion" to all participating teachers for six hours of "professional development activities." Not a nose in twenty but can smell what's stinking, said the Bard. And it's clear that the reward for signing up to this particular crusade will draw along increasing numbers of

PFLAG (parents and friends of lesbian and gay youth), that not long ago would have been prosecuted for contributing to the delinquency, indeed the physical destruction of minors. PFLAG quoted Kinsey's claims about the frequency and normalcy of perverse sex acts. "Being gay is as natural and healthy as being straight." These claims are demonstrably false. If the courts were not directed by politics, PFLAG would be sued for propagating these

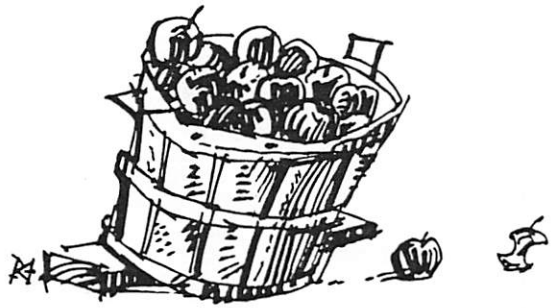
lies. Instead, Brian Camenker is being sued for exposing them, and the deadly places to which they lead.

An event like this would hardly be complete without the involvement of Planned Parenthood, dedicated to giving dangerous, cruel and unnatural acts a patina of health care and compassion. There they were, distributing zip-locked bags containing KY lubricant, plastic gloves, and instructions on how to make a "dental dam." According to Oliver, the packets carried the PP logo and phone number, and the message that dental dams "protects against STD's," like toothpaste, more or less. Doctors have made the obvious point that few people will eat sandwiches with the wrapper still on, and that adolescents given such material will proceed to experiment but discard the cumbersome and sense-depriving gizmos once underway. Spreading syphilis, gonorrhea, chlamydia, hepatitis and other diseases is not "as normal and healthy" as a straight, chaste-until marriage life, but PFLAG, PP, GLSEN and GLAAD are not pursuing truth or health with these kinds of advocacy events.

The Conference made plain that the enemy is those counseling sexual restraint and what have be-

finger opponents as "a new threat to Democracy and Diversity" as a brochure of the "Political Research Associates" claimed. The magazine, *Radical Teacher* carried articles on ways to circumvent or repeal "bans against faculty-student sexual relations," "Guerilla Sex Education in the Public Schools," and on ways to slip GLBT issues into various aspects of the 4-12 history curriculum, Arts and school athletics. They also promised information on "K-12 Radical Methods, Coming in May 2001."

Other developments, from national politicians and professional organizations and academics suggest that these matters will worsen before they improve. The American Psychological Association and its journal are continuing to promote efforts at "Deconstructing the Essential Father." As Dr. Jerald Rowles pointed out to me, an article of that name argues that rather than a benefit, the presence of fathers in families "increases women's workload and stress level." This is because men consume family resources on "gambling, purchase of cigarettes,



smoking create the impression that 90 percent of the victims of smoking (and thus, buying cigarettes) are women. They are victims, officially. Thus, psychologists must join the courts and politicians in vilifying and destroying traditional fathers, thus producing more fodder for the pedophiles and GLSEN-types. At the same time, President George Bush, Jr. has appointed former Massachusetts Governor Paul Celluci to be the next ambassador to Canada. Everyone in Congress and many people in the Administration have been alerted to Celluci's role in promoting and protecting "Fist-Gate" and its institutional support, carrying on the work of Michael Dukakis and William Weld. Is Paul supposed to fist away in Ottawa? Is this what the Canadians want? If Bush doesn't care, if he rewards rather than punishes such as Celluci, that raises fears about his administration's goals.

These background events were context for the trial of the murderers of Jesse Dirkhising. While the national media ignored the story, the government and its schools continued to "direct against an entire group of people"—namely, school children—indoctrination claiming that a spiritually and physically dangerous, even deadly way of living was "as normal and healthy as being straight." With these kinds of demoralizing lies (as well as drugs) being wholesaled, and sometimes re-tailed by sexually interested parties, it is no wonder that public schools

increasingly become places of overt physical violence. One hopes that people will not become numb to these events. Response from the Courts gives as little cause for hope as the attitudes and cadres now entrenched in the major media. The same day that the jury handed down a guilty verdict on Joshua Brown, a county Circuit Judge in Little Rock struck down the Arkansas law against sodomy because "it singles out homosexuals for prosecution." Judge David Bogard stated that homosexual sex "cannot be condemned just because it is different" (AP 03-23-01). But the ways in which it is different is precisely why it was proscribed.

Here again the attack of Modernism and modern politics on culture is clear. Proceeding from the democratic principle of "non-discrimination," equality before the law becomes a means of bulldozing extant distinctions and creating a new moral order. That this new order is immoral by all previous standards indicates that a revolution has occurred, and that the revolutionaries have largely succeeded in establishing new laws or legal interpretations and selling (or force-feeding) them to the populace via entertainment, commerce, the courts and the public education industry. In the absence of a sustained counter-revolution by the people, it is difficult to see this new and dangerous power structure being deflected from its goals. Any counter-revolution will have to generate and support its own methods of communication. The existing ones have been captured.

Heute betreibt der Anfang-Fünfziger einen eigenen Verlag, schreibt Bücher und gibt ein Magazin mit dem Namen „Cultur Wars“ heraus.

Die Kontakte nach Deutschland sind nie abgerissen. Die Ältesten beider der fünf Jones Kinder haben Teile ihrer Schulzeit oder des Studiums in Deutschland verbracht. Dieser Tage sind Mike und Frau Ruth in Rees zu Besuch. Während Mike vor 4 Jahren zuletzt hier war, liegt der letzte Deutschland-Besuch für Ruth schon 17 Jahre zurück. Kennt man sich da noch aus in Rees und Umgebung? „Aber sicher doch“, sind sich die Jones' einig. „Die Stadt ist viel schöner geworden. Es hat sich viel getan.
