RE: VICTORY FOR MARRIAGE AT ALEC

Coincident with the recent media feeding frenzy over gay marriage, on December 11, 2003, RSVPAmerica won by one vote a huge national victory for the protection of Marriage after four years of effort and political delays. (See former National ALEC Chair Ray Haynes' letter attached.) The American Legislative Exchange Council (ALEC), a national bipartisan membership and educational association for conservative state lawmakers, who share a common belief in limited government, free markets, federalism, and individual liberty, is going to publish an RSVPAmerica research paper for distribution to state legislators across the country. The legislators along with private sector members of the prestigious and respected ALEC Education Taskforce finally voted to publish and distribute an RSVPAmerica research paper under the ALEC auspices as an ALEC State Factor. The paper entitled Restoring Legal Protections for Women and Children: An Historical Analysis of the States Criminal Codes, provides potent authority for review and even repeal of laws based on the Kinsey "junk science" creating opportunity to restore laws more protective of Marriage on a state by state basis. (See attached Jeffrey report on meeting.)

The paper describes how 52 of America's founding state laws protective of marriage, women and children were systematically and deliberately undermined from 1955 through 1980 (based upon the ALI Model Penal Code, ("virtually a Kinsey document") to pave the way for the dissolution of the marriage institution through state courts. These 52 laws once pointed the way to promote and protect monogamous, faithful, marriages – period, (for example, in Missouri until 1979, it was illegal for anyone to mention "sexual intercourse" to a child under 21 unless it was a parent!). To teach sex education in schools required that prohibitive state laws on fornication and cohabitation be eliminated. The sexual revolution ultimately designed to remake Marriage depended upon the decriminalization of the 52 laws against activities like obscenity, seduction, adultery, etc., to permit all sexual activities between "consenting adults." Why? Prior to the covert legal revolution in state laws, ignited by the fraudulent science of The Kinsey Reports (1948-1953), the only lawful sexual congress in America was known as the "marital act," heterosexual coitus in marriage.

As conservative cries grow louder to mount a decade long national campaign to amend the U.S. Constitution in order to protect the institution of Marriage, this ALEC State Factor provides an authoritative source and opportunity to mount an effective offensive campaign now

in each state, which runs under the media radar of the more widely and hotly debated <u>defensive</u> Marriage Constitutional amendment effort.

Any battle to amend the Constitution is uphill and promises to be a long one, 1-2 years to pass 2/3^{rds} of both Houses of Congress and then another ten years some say to get 3/4 of the states to ratify the amendment to the Constitution. During this time in today's state courts, lawyers and judges have been and continue to be guided by the flawed ALI Model Penal Code/Kinsey doctrines.

The ALI Model Penal Code effort based on Kinsey's scientifically fraudulent view of "normal" human sexuality began as early as 1923. The ALI mission was to replace the fixed law standard based on Godly principles found in America's Common Law (the legal gold standard) with a changing and permissive standard based on Kinsey's sex science. The final blow to Marriage and the American Family is found in the ALI's recent book entitled *Principles of the Law of Family Dissolution*, adopted on May 16, 2000 and published in 2002, now in use as legal guidance in the law schools and the legal profession. Thanks to the ALI, marriage and families composed of moms and dads are being rendered obsolete in law schools and courts today.

"GAY MARRIAGE" IS ALREADY HARDWIRED INTO LEGAL EDUCATION AND PROFESSION

According to the *New York Times*, December 5, 2002, the American Law Institute "has wielded an extraordinary influence over American legal practices, since its founding in 1923." That is the understatement of the decade! In 1955, the ALI led a nationwide "science-based" penal law revolution with its model penal code recommendations. Now, after spending 10 years evaluating Family Law, the ALI's *Law of Family Dissolution* is yet another anti-Marriage guide book for lawyers and courts. The word "marriage" does not appear in the index. As the ALI declares, Marriage as currently defined in America has no status, because it "runs counter to the commitment this society avows toward family diversity."

The NYT's article goes on to say the proposals to repeal sodomy laws, give same-sex partners inheritance rights and extended health benefits to "partners" have stalled in many states, but the ALI's "findings may carry tremendous weight in U.S. courts." The ALI's Family Dissolution boasts, "even before its formal publication, the report had been cited in more than 100 law review articles and two dozen court decisions." Despite some 35 state legislatures having passed DoMA laws to define and defend marriage as between a man and a woman, the ALI has hardwired "gay marriage" into American life through the courts.

Bottom line: Despite We the Peoples opposition to the dissolution of marriage in many states, today in American courts the judge doesn't really need to know if the relationship was a matrimony, or a sodomite cohabitation, or a hetero cohabitation, or whatever. According to the ALI, Marriage is "non significant in the outcome of family dissolution." Any two people who live together for two years or more will now divide their possessions and retirement funds and children in an identical manner. Marriage is left for only the "maniacal moralists."

For custody purposes, "gays" don't need to redefine marriage, at least in terms of child custody, because the new legal system renders it a non-criteria. A judge determines that the children have been under the influence of any two people, who share expenses in the same household for two or more years, and determines the course of the children's lives based <u>only</u> on the <u>time and address of the litigants over the past two years</u>. Sodomites under this arrangement

really don't actually need "marriage" in the traditional sense. Is it a marriage, a "domestic partnership" a "civil union," <u>possibly polygamy</u>? The judge may not even ask. It doesn't matter according to the ALI guidelines being taught and in use <u>today</u>.

The ALI's principal author, Arizona State University, law professor Ira Mark Ellman, said the goal was to "close holes in family law that have left judges guessing as to how to deal with nontraditional families." That is ironic since the ALI, in effect, created the non-traditional family in law by recommending the elimination of the 52 state laws which once protected Marriage.

Finally, while the well intentioned efforts of so many will be directed to support the huge effort to pass a Constitutional Marriage amendment, the courts <u>TODAY</u> are dealing with a number of different cohabitation arrangements based on the ALI/Kinseyan "anything goes" standard. All types of unions will be well institutionalized with much precedent if and when the Marriage amendment is passed by Congress and ratified by three quarters of the states. Marriage will at best have a place at the legal relationship table, but will no longer be the only union sanctioned with full marital benefits in the practice of law.

Since 1994, the educational campaign of RSVP America has often been among local churches and civic groups in states across America to encourage and educate those called to defend Biblical principles in the public square about the harmful consequences from the amalgamation of the Kinsey Reports and the ALI Penal Law on marriage, women and children. The resultant "undemocratic" changes to law and public policy still need to be explained and connected for people as to how The Kinsey Reports directly and indirectly impact American life and law today. The campaign has largely accomplished the discrediting of Kinsey and his Reports as the on-line Britannica described Dr. Kinsey as follows:

Alfred Kinsey was a moral revolutionary in scientist's clothing. The science was bad, even bogus; the man himself may now be forgotten; but the revolution came to stay, with a vengeance. Kinsey's message – fornicate early, fornicate often, fornicate in every possible way – became the mantra of a sex-ridden age, our age, now desperate for a reformation of its own.

Law points the way. Will the sexual revolution be over by changing a few laws? No, there is no silver bullet, but there is a fixed gold standard in God's Word and He promised; "The hand of the diligent shall bear rule;" Proverbs 12:24. It took well-funded covert legal revolutionaries more than 80 years of diligent work to deconstruct marriage. When ALI lawyers and jurists began their covert revolution to free Americans from Victorian sexual repressions based on an "old fashioned" moral standard, there was great resistance from the public and media. Likewise it will take prayer and diligent action to regain so much lost ground, for today much of the public, some churches and certainly the media are not with us. We can take heart today for a first major battle has been fought and won in a national tribunal, ALEC. With your prayerful support, the work on the state level is going to happen sooner, if RSVP has anything to do with it, or later, when the campaign to ratify the amendment begins state by state.

The last hurtle is the costs of the national campaign for the year (July 1, 2004 – June 30, 2005) including private efforts to publish and distribute and brief costs to print and distribute the ALEC research to more than 3,400 state legislators and other leaders along with related travel,

etc. nationally which RSVP America has to provide. In addition, at least another 10,000 copies of the underlying Monograph for our private distribution need to be printed at a similar cost. Your support of the RSVP America campaign will provide the financial support to make that happen. We will need your continued prayerful support to print and distribute the ALEC State Factor and finish the Campaign. (See attached budget).

The Kinsey Movie - 2004

On a related front, there is a major movie planned on Alfred Kinsey for release in 2004, which is in large part because the RSVPAmerica campaign with the prayers and financial assistance of our friends has been so successful in exposing the Kinsey frauds. Hollywood is coming to the rescue with an attempt to resurrect Kinsey's sagging and sullied image. The sex industry (porno, abortion, etc.) and sex academia (sex education) are already coming to Hollywood's aid. They can't withstand the truth about the Kinsey fraud getting out because there's too much taxpayer money riding on it.

RSVPAmerica intends to send a copy of the actual movie poster to lawyers, judges, legislators, etc., with information on the Kinsey frauds on the back. The back of the poster would also allow us to promote distribution of the ALEC State Factor and our supporting state-by-state monograph which gives greater indepth information on the un-American changes which "abolished" the 52 state laws that once supported marriage.

The Kinsey movie is not made to be a box office hit, but rather a movie Hollywood was making for its own propaganda reasons. That would be "religious" reasons, pagan religious reasons.
