## WHY DOES AMERICA TOLERATE PEDOPHILIA?

"We shall sodomize your sons.... We shall seduce them in your schools, in your dormitories, in your gymnasiums, in your locker rooms, in your arenas, in your seminaries, in your youth groups, in your movie theater bathrooms, in your army bunkhouses



.... Your sons shall become our minions and do our bidding," wrote Michael Swift, homosexual poet for the February 2, 1987 issue of *Gay Community News*.

When confronted with the Swift statement, homosexuals flatly deny such an agenda, excusing Swift on the grounds that he is a poet. *Washington Dateline* believes mounting evidence proves that Swift was promoting sexual, not poetic, license, and that this agenda to sodomize America's youth is being carried out with military precision.

Mary Sanchez, writing for the *Kansas City Star* reported in October, "A national group that wants to inject homosexual references into school curriculum has donated books about teenagers exploring their homosexuality to 42 area highschools." Sanchez wrote that Robert Birle is coordinator and co-founder for the group named Project 21. Two of the books are already in some of the schools: *Annie On My Mind* by Nancy Garden and *All-American Boys* by Frank Mosca, which, reports Sanchez, "follows the story of two homosexual teen-age boys."

According to Sanchez, Don Shirley, director of library services for the Shawnee Mission school district, has said, "We will use the same criteria we use to choose any of our other materials." Does

he equate propaganda for perversion with the classics? Sanchez also quotes Shirley, "The Shawnee Mission district has not received any complaints from parents about the Nancy Garden book." Why haven't parents complained about this blatant effort to promote perversion? Are they ignorant or do they just NOT care; or is the school district pigeon-holing their complaints?

Project 21 was started in 1990 in California and also operates in Kansas, Iowa, Nebraska, Oklahoma, Texas, Minnesota, and Oregon. This year, in California, the Bay Area Network of Gay and Lesbian Educators received a \$4,000 United Way grant to donate books with homosexual themes to schools in the San Francisco area. And yet, there has been no public outcry about such irresponsible grant-making.

Earlier this year, a pedophile group had a quiet chat in the busy atrium of the Citicorp building in mid-Manhattan. The gathering was videotaped and part of the footage was shown on New York's Channel 4. John Leo, writes in *U.S. News and World Report* (Oct 11, 1993) that the "pedophiles were all members of NAMBLA, the 1,000 member North American Man/Boy Love Association, which wants the law to allow adults to have sex with children."

Leo wrote that one pedophile who was unaware that he was being videotaped was "a public school teacher, [who] urged another, a public school librarian, to keep his membership secret until he has tenure." Another member of the NAMBLA meeting had been a school psychologist working with emotionally and physically handicapped children at a Queen's elementary school.

John Miller, the WNBC-TV correspondent who broke the story in March said, "We thought these guys were people who lurk around outside schools. What we found was, they lurk around *inside* the schools." Miller has a point, wrote Leo. "They apply for jobs at schools, camps, the Boy Scouts, Big

Brothers, YMCAs. 'Boy lovers' love to work where they boys are." This dovetails with Swift's plan for perversion as described in his work "For the Homoerotic Order" as first reported by WASHINGTON DATELINE in 1987.

John Leo's article reveals that Peter Melzer, 53, is "the teacher on the WNBC-TV tape who advised the librarian to lie low." Melzer teaches physics and science at the elite Bronx High School of Science. "He is on the NAMBLA steering committee and the editorial board of the *NAMBLA Bulletin* which has offered advice on how to entice a child into sex ('Leave a pornographic magazine some place where he's sure to find it.')

On October 14, a week after the Leo story, the AP reported, "about 1800 Scoutmasters suspected of molesting boys were removed by the Boy Scouts of America from 1971 to 1991, but some simply went elsewhere and continued to abuse Scouts, organization files show."

Some homosexuals and lesbians say they "detest" NAMBLA and pedophiles; but the International Lesbian and Gay Association has called on members "to treat all sexual minorities with respect," and NAMBLA is a member of that organization.

Leo asks, "Is there a creeping tolerance?" He should direct the question to President Clinton who told representatives of the homosexual movement, "I stand with you in the struggle for equality."
